3 **AN ORDINANCE OF THE ALBANY CITY COUNCIL REPEALING CHAPTER VII**
4 **CITY OF ALBANY CAMPAIGN FINANCE REFORM ACT OF 1996 OF THE ALBANY**
5 **MUNICIPAL CODE**

6 **WHEREAS**, the City Council directed staff at its July 20, 2009 city council meeting to
7 place on the City Council agenda an ordinance to repeal the Campaign Finance Reform Act of
8 1996.

10 **NOW, THEREFORE, THE ALBANY CITY COUNCIL ORDAINS AS FOLLOWS:**

11 **Section 1: Publication**

12 The City of Albany Campaign Finance Reform Act of 1996, contained in Chapter VII
13 Sections 7-1.0 through 7-11.0 is hereby repealed in its entirety.

14 **Section 2: Publication**

15 This ordinance shall be published in a newspaper of general circulation in the City of
16 Albany, which said newspaper is designated for that purpose, or it shall be posted in three
17 locations.

18 **Section 3: Severability**

19 If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason
20 held to be invalid, such decision shall not affect the validity of the remaining portions of the
21 ordinance, and each section, subsection, sentence, clause, or phrase thereof, irrespective of the
22 fact that any one or more sections, subsections, sentences, clause or phrases be declared invalid.


23 **Section 4: Effective Date**


