

WATERFRONT COMMITTEE REGULAR MEETING MINUTES

City Council Chambers October 4, 2007 – 7:30 pm.

1. CALL TO ORDER

Parker called the meeting to order at 7:33 pm.

3. APPROVAL OF MINUTES

3-1. Approve minutes from September 6th meeting

Minutes approved unanimously, with corrections.

4. PUBLIC COMMENT

5. REPORTS

5-1. Burrowing Owl Habitat – Update

Chaney provided an update. The City Council authorized staff to go out to bid on the project, approved the agreement between City and East Bay Regional Park District (EBRPD) on maintenance and monitoring, and authorized staff to contract with a wildlife biologist. The project is expected to begin during Fall 08.

5-2. Beach Restoration – Update

Parker suggested item be postponed to a future agenda.

5-3. Bulb Cleanup – Update

Chaney provided an update and distributed photos. The City's Public Works and Police Department worked in conjunction with the Conservation Corps to clean out unoccupied homeless encampments only.

Public Comment:

Carol O'Keefe – asked if Police Department has taken a count of occupied encampments.

Chaney stated the Police Department does have a count demarcated on aerial maps. There are about ten occupied camps.

5-4. Soil Reuse from GGF Track resurfacing

Chaney provided information to Diehl, and has been in conversation with GGF and East Bay Regional Park District (EBRPD). EBRPD has accepted soil and it is now located near Virginia Street on Eastshore State Park property.

6-2. Waterfront Planning Process – review of letter to City Council (to be forwarded to Committee October 1st)

Parker distributed a revised version of the draft letter for City Council. Larson distributed an email that requested a minority recommendation also be included within the letter.

So provided several edits to clarify the letter, and would like language to specify that the Committee reviewed the draft report and not a final report. Diehl and Holan provided edits to clarify language in the letter.

Holan asked if the final report had been completed.

Chaney stated the report should be available no later than Monday. The Planning and Zoning Commission did not take formal action at their meeting regarding the draft report.

Parker agreed to include the minority recommendation in the letter.

Dann motioned that the letter be approved as amended. Seconded by Diehl.

Unanimously approved. Granholm abstained.

Parker will revise letter and submit to Chaney for transmittal.
