RESOLUTION #09-45

A RESOLUTION ESTABLISHING DAYS, TIMES, AREAS AND EVENTS WHEN NO DOGS ARE ALLOWED ON THE SPORTS FIELD AT MEMORIAL PARK

WHEREAS, the Parks and Recreation Commission discussed at several Commission meetings and Community meetings alternatives and solutions for the issues raised concerning dogs in Albany parks, and

WHEREAS, the City Council approved additional language to the Albany Municipal Code section 10-4.2 to provide for flexibility in designating areas and times when dogs can be in parks; and

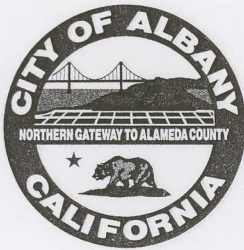
WHEREAS, the additional language to the Albany Municipal Code states that specific times, days, and areas be adopted via resolution after considering recommendations from the Parks and Recreation Commission;

NOW, THEREFORE, BE IT RESOLVED, that for a pilot period of one year, no dogs are allowed on the sports field at Memorial Park during the following days, times, and events:

- (1) Saturdays from 12:00 p.m. to 6:00 p.m.;
- (2) Mondays and Thursdays from 4:00 p.m. to 7:00 p.m. during daylight savings time;
- (3) Mondays and Thursday from 4:00 p.m. to 6:00 p.m. during standard time;
- (4) When a field user has acquired a permit through the City of Albany for use of the sports field.

Times, days, and events when no dogs are allowed will be posted at the ball field.


