SUBJECT: June 30, 2009 Financial Statements and Reports of the Independent Auditors

STAFF RECOMMENDATION

Receive presentation by the City's independent auditors of the results of their examination of the City's financial reports for fiscal year end June 30, 2009.

BACKGROUND

The City Council has engaged the Certified Public Accounting firm of Caporicci & Larson, CPAs, to serve as independent auditors of the City's financial reports. The scope of work performed by the auditors encompassed examinations of the City's Comprehensive Annual Financial Report, the annual financial reports of the Albany Reinvestment Agency, the Albany Police and Fire Relief or Pension Fund, ACTIA Measure B Funds, Transportation Development Act Report, federal single audit, and the City of Albany Appropriation Limit. The auditors also report to the City Council their findings and recommendations regarding the City's internal control structure and compliance with terms of grant agreements.

DISCUSSION/ANALYSIS

Comprehensive Annual Financial Report (CAFR)

The independent auditors' reports, which appear on page A1 of the City of Albany Comprehensive Annual Financial Report is an unqualified report, meaning that the auditors report that the financial statements present fairly, in all material respects, the financial position of the City at June 30, 2009. This is the highest level of auditor assurance the City can achieve in an audit.

The Comprehensive Annual Financial Report (CAFR) presents financial information on the status of the City's financial affairs, first on a city-wide basis (*Government-wide Financial Statements*) in which all City activities are reported as either governmental activities and business-type activities. A second set of statements (*Governmental Funds Financial Statements*) report separately the activities of 54 funds:

Major Funds

- General Fund
- Civic Center Improvement
- General Obligation Bond II

Proprietary Funds

- Sewer Enterprise Fund
- Internal Service Funds (3)

Fiduciary Funds

- Pension Trust Fund
- Agency Funds (4)

Special Revenue Funds (21)

Other Capital Projects Funds (15)

Debt Service Funds (6)

The lead document in the CAFR is a Transmittal Letter, which includes information regarding the City's demographics, accounting and budgetary controls, four reporting entities within the City, descriptions of the 9 departments within the City, discussion of the economic outlook for the coming year, and summaries of major initiatives currently active within the City.

Management's Discussion and Analysis (MD&A) of the City's financial activities for the year is the first document in the Financial Section of the CAFR. Following the financial statements is the statistical section of the report, which includes tables that contain seven or eight years of data so as to illustrate financial trends, and the section also includes demographic and other data that is useful in analyzing the financial condition and performance of the City.

The comprehensive format of the annual financial report is designed to provide detail information for all activities of city government in one document, but it is not designed to be read cover to cover. We suggest that users initially concentrate on the summary schedules in the MD&A before moving to the full statements, budget comparison statements and combining statements that are presented in the financial section of the report.

General Fund – This fund encompasses the core operations of the city's governmental functions. All revenues not specifically dedicated to a specific purpose are recorded in this fund, and the costs of basic services of safety, public works, recreation and administration are recorded in the general fund. General Fund activities are guided by a detailed budget, and quarterly financial reports compare the budget and actual revenues and expenditures. The fund balance of the General Fund is an important measure of the

financial condition of the City, and the net increase or decrease in the undesignated fund balance is an important measure of the City's operations for the fiscal year.

In our September 21, 2009 report to Council, of the unaudited preliminary financial results for the year, we reported an increase in the Unrestricted General Fund balance of \$188,075 from current operations and a total ending fund balance of \$4,966,777. The final audited results for the year were an increase in the Unrestricted General Fund balance of \$246,335, and a total ending fund balance of \$5,025,037, of which \$3,560,007 is unreserved and undesignated.

A comparison of actual to budget for the year is shown on page A14 of the MD&A. Revenues exceeded budget by \$894,000, the major variances were:

- *Property taxes* – exceeded budget by \$128,000. This 2.6% favorable budget variance was largely the result of supplemental taxes assessed to property sold during the year.
- *Sales taxes* – exceeded budget by \$214,000. This 10.6% favorable variance represents an increase of \$40,000 over fiscal year 2008-09, whereas we had reduced the budget in line with the widely forecasted economic downturn for California and nationwide. The economic downturn did materialize, but retail activity in Albany bucked the trend with several of the City's major sales tax generators.
- *Franchise and Other taxes* – exceeded budget by \$127,000. This 3.4% favorable budget variance was mostly due to property transfer tax revenue, which declined from the prior year by \$195,000 but exceeded the budget, which had been lower in recognition of the decline in real estate sales, by \$130,000. Race track taxes exceed the downward adjusted budget by \$58,000. These favorable variances were partially offset an unfavorable variance of \$64,000 in utility user taxes, which had not been budgeted to decline.
- *Services charges and Other revenue* – exceeded budget by \$366,000. The most significant item being the reimbursement of wages and benefits for fire fighters/paramedics who served in strike teams for Southern California wild fires.

Total General Fund expenditures were \$66,000 below budget. This favorable balance reflects under budget variances \$153,000 in Police and \$173,000 in Community Development and Environmental Resources, partially offset by unbudgeted capital expenditures of \$151,000, and personnel expense for Fire of \$93,000.

Interfund transfers – Transfers between the General Fund and other special purpose funds are most often made to match related revenues and expenditures, they are also used to fund reserves for future major expenditures or accrued liabilities.

Transfers-in to the General Funds of \$3,286,000 were made to cover expenditures recorded in the General Fund as follows:

- Sewer maintenance and operations \$ 798,000
- Paramedic services 1,247,000

- Landscape & Lighting bonds and operations 35,000
- Gasoline tax 356,000
- Pension Override tax 850,000

Transfer-out of the General Fund of \$977,000 were made for the following purposes:

- Self-insurance reserves \$ 278,000
- Capital projects 600,000
- Police and Fire replacement reserves 99,000

Government-wide Financial Statement - On the combined activities basis the schedule on page A8, shows the City to have net assets of \$56.1 million with a ratio of assets to liabilities of 2.4. The ratio of asset to liabilities declined from 2.5 in the prior year, principally as a result of the issuance of the parcel tax note of \$3.5 million.

Auditors' Report to City Council

Each year, the independent auditors report to the City Council any material findings regarding internal accounting controls, management's compliance with generally accepted accounting principles, management's judgment in applying accounting estimates, disagreements between the auditors and management, and difficulties performing the audit. The auditors reported no finding in the current or previous examinations.

Albany Reinvestment Agency

The auditors issued an unqualified opinion on the financial statements of the Albany Reinvestment Agency, and reported no findings of material weaknesses.

Net assets of the Reinvestment Agency increased \$193,177 to a balance of \$803,191. The Low & Moderate Housing Fund, the Capital Projects Fund, and the Debt Service Fund have fund balances of \$493,693, \$282,414, and \$27,084 respectively.

Police and Fire Relief or Pension Fund

The auditors issued an unqualified opinion on the financial statements of the Police and Fire Relief or Pension Fund, and reported no findings of material weaknesses.

There are 29 vested participants in the pension plan. The plan has an unfunded actuarial liability of \$1,886,363 at June 30, 2009. City staff has recommended a contribution to the Fund of \$300,000 for fiscal year 2009-10.

ACTIA Measure B Funds

The auditors issued an unqualified opinion on the financial statements of the Alameda County Transportation Improvement Authority Measure B Funds, and reported no

findings of material weaknesses or non-compliance with the agreement between the City and ACTIA.

Revenues for fiscal year 2008-09 were \$483,841 and expenditures were \$523,165, as compared to revenues of \$427,091 and expenditures of \$439,507 for fiscal year 2007-08.

Single Audit

The auditors performed an audit of federal grants in excess of \$500,000 of federal expenditures and reported no questioned costs or compliance exceptions.

City of Albany Appropriation Limit

The auditors performed agreed upon procedures, as specified in their report, on the City's calculation of the annual appropriation limit (Gann Limit) for the fiscal years ending June 30, 2009, and June 30, 2010. They noted no exceptions in the calculation.

The fiscal year 2008-09 appropriation limit is \$13,781,439 and the fiscal year 2009-10 limit is \$14,040,530. We project that future expenditures will not exceed the applicable limit.
