### 1. CALL TO ORDER

### 3. APPROVAL OF MINUTES

3-1. Members Bailes moved and Baty seconded approval of the minutes of the May 24, 2010 meeting. The minutes were approved unanimously with Grossman abstaining and Holan not yet present.

# 5. DISCUSSIONS AND POSSIBLE ACTION ON MATTERS RELATED TO THE FOLLOWING ITEMS:

## 5-1. Follow up on City Attorney elected/appointed ballot process

The Committee discussed means of informing the public about this ballot measure. The Committee decided that the primary topic of its September meeting should be presenting the public with information about the measure and would pursue additional outreach to let the public know about this meeting. Member O'Keefe committed to contacting the City Clerk regarding highlighting this meeting on the City's home page. Additional publicity options were notices in local media such as Patch, The Journal and Albany Today.

The Committee also desired a second public outreach event, preferably on a Saturday. Participating in the likely League of Woman Voters event regarding the council candidates was the most desirable option. Member Holan committed to contacting the League. If participation in this event was not possible, the Committee's second choice was to hold a meeting on the first Saturday in October.

It was also suggested to make presentations regarding the measure to various community organizations, such as the PTAs, Rotary, Senior Center, Solano Avenue Association, Chamber of Commerce, Green Party, Democratic Party Central Committee, and Sierra Club.

The Committee wondered if the current City Attorney would endorse the measure or sign the argument for or rebuttal to the argument against the measure.

The Committee selected members for the ballot argument committee. Members Bailes, Holan and Jordan agreed to serve on the committee drafting the argument for the measure, which Mayor Wile and Councilor Atkinson had already been appointed to by the Council. Member Bailes was to contact the Council members regarding establishing a time for the first meeting of this committee. Member Jordan was to contact Chair Wallace about serving on the committee in his place if possible. Member Baty was to substitute for Member Holan on the committee regarding drafting the rebuttal to the argument against the measure.

### 5-2. Follow up from City Council June 21 meeting – City Administrator position

At its June 21<sup>st</sup> meeting, the Council asked the Charter Review Committee to provide the reasons for its unanimous recommendation against changing the title of the City Administrator to City Manager without providing department hiring and firing responsibility. Committee members offered the following reasons to be conveyed to Council: change in title without this change in responsibility could create problems during future recruitment efforts, cause confusion in the city administrator/manager peer group, be disrespectful to the current city administrator, be disrespectful to other city managers, and is unresponsive to the original reason this change was suggested in the CityGate report.

### 6. ANNOUNCEMENTS/COMMUNICATIONS

Member Jordan announced that The New America Foundation's political reform program had collapsed due to loss of funding from a major sponsor. Blair Bobier, who provided a well received presentation on ranked choice voting as it could be used in Albany to some Charter Review members and the public at the October 2009 meeting, which was canceled for lack of quorum, is no longer employed by the Foundation.

Discussion of Member Grossman's desire for a city government performance review Follow up on the City Treasurer qualifications requirements Reform of City Council elections

Outcome of recommendation that the Council use cumulative voting when making multiple Council-as-whole appointments to a single advisory body
