5. GOOD OF THE CITY/PUBLIC FORUM/ANNOUNCEMENTS

Mayor Wile opened the Good of the City/Public Forum/Announcements and the following people spoke.

Fire Chief spoke on the recent gas explosion in San Bruno and noted that Albany sent a strike team to the explosion. Also noted that PG&E is non committal at this time but would be releasing a list of where the gas mains are located.

Joan Larson, Albany Historical Society; Jean Safir, League of Women Voters (LWV); Allan Maris, Albany resident. A summary of the comments is as follows: Spoke about the StoryTime sponsored by the Historical Society and Transitional Albany and thanked everyone that participated. Announced the Council Candidate Forum sponsored by the LWV on October 7, 7:30 – 9 p.m., at the Council Chamber, 1000 San Pablo Avenue, Albany. Spoke about Campaign Financing Reform and Candidate spending and the fact that Albany does not have Campaign Financing on the books.

The following announcements were made by staff and Council: 1) Smoke Testing on Albany Hill beginning tomorrow. 2) October 18th is the deadline to register to vote for the November election. 3) Global Action Day – carbon footprint, is scheduled for 10/10/10. 4) September 25th is Cleanup Day. 5) A press conference was held involving Mayor Wile to discuss AB234, which has to do with prebooming for oil tankers, which Albany supports.

There being no one else wishing to speak Mayor Wile closed the Good of the City/Public Forum/Announcements.

6. PRESENTATION/PUBLIC HEARING

6-1. Resolution No. 2010-47 – Richardson Redwood Grove

Council Member Lieber stated that he has bought this Resolution to the City Council for action and officially opposing the Highway 101 Project that endangers the Richardson Redwood Grove.

Council Member Lieber noted that it is time for everyone to step forward to preserve this area. The project was approved for funding on June 30 by the California Transportation Commission for the widening and straightening of the highway project through Richardson Redwood Grove State Park. This project threatens to destroy one of the few remaining stands of irreplaceable ancient redwoods in a State Park. The argument used for this project is based in the "need" to allow oversize trucks to travel up Highway 101, from LA and the Bay Area to Humboldt and Del Norte Counties.

Council Member Lieber noted that some trees that are not old growth would be cut down, but most importantly, the root systems of at least 72 ancient redwoods would be carved up and moved out of the way, compromising the survival of those trees directly.

The following people spoke in favor of Resolution No. 2010-47 and urged the Council to pass it: Bob; Nicole; Karen Pickett; Bob Stern; Jack; Leslie Novel; Deanna; Allan Maris.

6-1. Resolution No. 2010-47 – Richardson Redwood Grove

A summary of the Council comments is as follows: Everyone should write to the Governor and their representatives. Agree with what has been said but believe the Council should not take this action but individuals should contact the Governor and representatives. Stated that although agree with everything that has been said tonight has not had enough time to research the entire project and could not vote for it until he knows all the details. Council Members Thomsen & Javandel noted that they would be abstaining on the vote. Thanked Council Member Lieber for bringing this to the Council's attention.

Council Member Lieber presented Resolution No. 2010-47 – A Resolution of the Albany City Council in Opposition to the Highway 101 Project that Endangers the Richardson Redwood Grove.

Mayor Wile asked the Recreation Supervisor to read the Proclamation, as she is the staff liaison to the Arts Committee. The Proclamation was read in its entirety and the Arts Committee members were introduced to the Council and public.

Mayor Wile presented the Proclamation to the Chair of the Arts Committee.

7. UNFINISHED BUSINESS

7-1. Public Art Master Plan

(File #900-30)

The Recreation Supervisor presented the staff report noting that in October, 2007, the City adopted the Art in Public Places Ordinance. The purpose of the Ordinance is to promote the acquisition, construction, installation, restoration, and maintenance of public art pieces in Albany.

The key source of funding established by the Ordinance is a 1.75% for-art fee on new developments over \$300,000. The fee requirement can be satisfied with inclusion of public art in each project directly or paid into a Public Art Fund to be used in focused areas throughout the City.

7-1. Public Art Master Plan

In October, 2009, Huss/Laczko Consultants were hired to draft the Public Arts Master with the Arts Committee. The Consultants conducted a comprehensive physical survey of the City to identify key sites for the display of public art.

To gather input, the Consultants held two workshops with the Arts Committee, informal interviews were held with stakeholders identified by the Arts Committee, a presentation board was displayed at the Community Center. The Master Plan was presented to the Planning & Zoning Commission and the Parks & Recreation Commission. The final draft of the Public Arts Master Plan was presented to the Arts Committee on July 12, 2010 for approval.

The Public Arts Master Plan creates a "roadmap" with planned uses for key sites and establishes priorities that reflect the community's particularities. The core of the plan is a survey of sites by geographic location where opportunities for public art could occur. For each site, criteria has been established such as site ownership, funding source, time and media such as sculpture, flatwork, tile, mural, glass and media art.

The Consultants, Steve Huss and Brian Laczko were introduced to the council. The following people spoke: Ray Anderson, Albany resident and a summary of the comment is as follows: Expressed concern about the funding for this project and believes that the 1.75% is very high.

A summary of the Council comments is as follows: Disagreed with the previous speaker and noted this is the adoption of the Plan and supports this living document. Appreciate the matrix that was prepared and how the City was divided up with rankings. Support the Plan and believe it could be used to make people feel welcome in the City. Thanked the Community and the Consultants for a very well organized Plan. Liked the process that was used especially the display at the Community Center and is looking forward to seeing the projects completed.

Council Member Javandel presented Resolution No. 2010-38 – A Resolution of the Albany City Council Adopting the City of Albany Public Arts Master Plan.

7-2. Council Health Benefits

(File #720-40)

The City Manager reported that Council asked staff to bring back a survey of benefits received by Council Members is other cities. This survey was completed and included all aspects of compensation to Council Members not just health benefits.

The question before Council is whether they cap the benefit at the Kaiser family rate, as is done for all City employees or continue with no cap.

7-2. Council Health Benefits

The following people spoke: Caryl O'Keefe, Albany resident; Brian Parsley, Albany resident.

A summary of the comments is as follows: Expressed concern that the Council have better benefits than the employees and believes there should be parity for Council and would recommend changing the policy retroactively. Agreed that Council should not have better benefits than the employees and that they should be capped at the Kaiser rate and would like to see the survey broken down.

A summary of Council comments is as follows: The City Council are not employees but elected representatives and do not support any change to the Council benefits at this time. Believe there should be parity and the health benefit should be capped just as the employees have a cap and support the Kaiser cap for Council. It was noted that one Council Member is already paying the difference. Council should do the correct thing and have parity with its employees and agree with the Social & Economic Justice Commission recommendation. Do not agree with the recommendation and is not in favor of changing at this time. Appreciate the work done by the Social & Economic Justice Commission and agree that no change should be made at this time.

Moved by Council Member Thomsen, seconded by Council Member Javandel to support a cap on Council health benefits the same as the employees, which is capped at the Kaiser family rate.

8. NEW BUSINESS

8-1. Storm Water Permit

(File #1030-10)

In 1991, Alameda County, its 14 cities and two special districts, created a Joint Powers Agreement called the Alameda Countywide Clean Water Program (ACCWP) to comply with mandated National Pollutant Discharge Elimination System (NPDES) permit requirements issued by the San Francisco Regional Water Quality Control Board (SFRWQCB).

The most recent NPDES permit was adopted in 2009 and imposes several new and costly mandates on the permittees. The ACCWP legal counsel was asked to conduct analysis to determine whether the permittees to the Municipal Regional Permit (MRP) may be eligible to recover costs associated with implementing new requirements imposed

by the MRP under the State's "unfunded mandates" law. Legal counsel has determined that it is beneficial to pursue filing of a joint test claim.

No one from the public spoke.

MOTION:

Moved by Council Member Thomsen, seconded by Council Member Javandel to authorize staff to: 1) Prepare a test claim to the California Commission on State Mandates for particular costs associated with the City's Municipal Regional Storm Water Permit. 2) Work in coordination with the other agencies within Alameda Countywide Clean Water Program regarding the test claim filing and review process. 3) Execute an engagement letter and authorization to Meyers Nave to serve as the lead counsel to file the test claims on behalf of the agencies within the Alameda Countywide Clean Water Program.

8-3. Operating Agreement with East Bay Regional Communications Systems Authority

(File #600-40)

The City Manager reported that the East Bay Regional Communications Systems Authority (EBRCSA) was created as a Joint Powers Authority in 2007. The goal is to develop and operate a state of the art radio communications system that would provide regional interoperability.

The new system would replace a patchwork of systems currently in use in Contra Costa and Alameda counties. The estimated cost to complete the new system is \$69,952,910. EBRCSA has secured approximately \$39 million in funds from the Bay Area Super Urban Area Security Initiative, State Homeland Security and COPS grant programs.

To date, funds have been used to develop the system and purchase equipment. The West Contra Costa County Cell is now complete and will be available for use once the testing is complete. The East Alameda County Cell is 80% complete and expected to be operational by the end of the year. The full system is targeted to be up and available to all system users prior to January 1, 2013.

After careful review, the City has determined at this time it can operate with a total of 74 radios and based on this count, Albany's share is estimated at \$114,330. To finance the radio purchase it would cost \$15.65 per radio per month for 15 years for a total outlay of \$173,715 instead of \$114,330 up front. The monthly operating and maintenance charges are currently estimated at \$29.17 per radio or \$21,585 annually beginning in FY 2013-14.

No one from the public spoke. A summary of the Council comments is a follows: Agreed that it is important to have a communication system that links all emergency services. Supported the program and noted that San Mateo has a countywide system,

which worked well in the recent gas explosion disaster. It was agreed that the costs should be paid up front.

Council Member Thomsen presented Resolution No. 2010-49 – A Resolution of the Albany City Council Approving a Project Operating Agreement with the East Bay Regional Communications System Authority (EBRCSA) and Authorizing the Execution and Implementation of Same.

8-3. Alternatives for Management of the Fire/Emergency Medical Services (EMS) Department

(File #520-10)

The City Manager reported that Fire Chief, Marc McGinn, has tendered his resignation but is working on a contract for services for a limited term. The term of the contract runs until mid-February, 2011 with an option to extend upon mutual agreement. The contract is for salary only at the approved Fire Chief level, without benefits, starting at 40 hours week with a reduction to 30 hours per week beginning mid-November.

The Fire Chief has served the City for than 32 years and during his tenure has overseen many advances in services to the community, most notably the expansion of the paramedic program and enhanced fire prevention efforts.

As noted in the 2009 Organizational Analysis the fire and emergency medical services have been experiencing an increasing amount of regulation, standards, training, technology and technical requirements. As a result, more and more fire agencies have or are looking to combine efforts to achieve economies of scale and is particularly prevalent among smaller agencies that wish to spread its management and other overhead costs across more than a few or less fire stations.

The City Manager stated that with the retirement of the current Chief it is an opportune time to explore alternatives for fire management services in the City. Alternatives include a shared chief, contracting for chief services and/or other regionalization options such as a joint powers authority.

The following people spoke: Allan Maris, Albany resident; Brian Parsley, Albany resident.

A summary of the comments is as follows: Cautioned the Council to take a long term look at this and noted that if changed the City may not get the same fast response time. Suggested that as well as looking at alternatives that the City should be looking for a Fire Chief.

A summary of the Council comments is as follows: Agreed that it is time to look at alternatives, however, definitely want to maintain the current response times and have

EMS service in the City. Noted that it is definitely wise to look at alternatives, however, is not interested in changing the current operating structure. Need to wait and see how 8-the alternatives work out. It was suggested that the current personnel be included in the process.

The City Manager recapped that the City still wants to maintain its EMS service and is just looking at the management aspect of the Department.
