## 5-1. Dog management at Albany Waterfront - subcommittee status report regarding survey pilot

Dann and Papalia conducted the pilot survey.

Dann noted that there is a lot of writing to conduct the survey.

Donald agreed that the subcommittee should do some additional work on the survey.

So would like the survey to be more comprehensive, with less writing, and more representative.

Diehl recommended the subcommittee revise the survey based on the Committee's comments to make it easier to use and generates meaningful responses.

Donald recommended getting an idea of times of use, and a comment area would be helpful. The subcommittee will work to revise the survey.

# 5-2. Request by Live Nation to hold a benefit concert by the band Green Day on September 3, 2010 in the north parking lot of Golden Gate Fields (Staff Report to Planning and Zoning Commission for conditional use permit attached).

Chaney reported that Live Nation is seeking a conditional use permit to hold a general admission concert at Golden Gate Fields. A portion of the proceeds will go to the school district. Golden Gate Fields has a standing use permit with the City, but it does not include musical events. Chaney reviewed the conditions of the use permit. A noise study was conducted by a consultant finding that the ambient noise would be in compliance.

Diehl moved that the Committee support approval of the use permit on the condition that the following items be addressed: that trash be dealt with immediately following the event, areas are more specific of where trash may be including Albany lands, prompt exiting of people and cars, additional recycling containers near the park, and that sufficient lighting is provided to conduct appropriate cleanup. Seconded by So. Unanimously approved.
