

1 **RESOLUTION NO. 2010-60**

2 **A RESOLUTION OF THE ALBANY CITY COUNCIL, COUNTY OF ALAMEDA,**  
3 **STATE OF CALIFORNIA, DECLARING THE RESULTS OF THE GENERAL**  
4 **MUNICIPAL ELECTION HELD ON NOVEMBER 2, 2010.**

5 **WHEREAS,** a General Municipal Election was held and conducted in the City of  
6 Albany, County of Alameda, State of California, on November 2, 2010, as required by  
7 law; and

8  
9 **WHEREAS,** it appears that notice of said election was duly and legally given,  
10 that voting precincts were properly established, that election officials were appointed and  
11 election supplies furnished, and that in all respects said election was held and conducted,  
12 and the votes cast thereat received and canvassed and the returns thereof made and  
13 declared in the time, form and manner required by law; and

14  
15 **WHEREAS,** the City Council of the City of Albany met at the Council Chambers  
16 of the City Council on Monday, December 6, 2010 to canvass the returns of said election,  
17 as a result of which the City Council finds the number of votes cast, the names of the  
18 persons voted for, and other matters required by law to be as hereinafter stated.

19  
20 **NOW, THEREFORE, THE COUNCIL OF THE CITY OF ALBANY DOES**  
21 **HEREBY RESOLVE AS FOLLOWS:**

22  
23 That said Municipal Election was held and conducted in the City of Albany on  
24 Tuesday, November 2, 2010, at the time and in the form and manner as required by law.

25  
26 That there were thirteen (13) precincts, numbered 260100 to 262100, inclusive,  
27 which said precincts were established for the purpose of holding said election, being  
28 regular election precincts and that all of said precincts are the same as those established as  
29

1 of record of the Board of Supervisors of the County of Alameda for holding regular State  
2 and County elections.

3  
4 That the whole number of votes cast in the City of Albany was 7246.

5 That the names of the persons voted for, the offices for this they were voted, the  
6 number of votes given in each precinct to each of said persons, together with the whole  
7 number of votes which they received in the entire City, are as follows: See Attached  
8 Certification from the Registrar of Voters.

10 **BE IT FURTHER RESOLVED THAT:**

11 **JOANNE WILE**, was elected to the Office of Council Member of the City of  
12 Albany for a term of four (4) years; also that

13  
14 **MARGE ATKINSON** was elected to the Office of Council Member of the City  
15 of Albany for a term of four (4) years; also that

16 **ROBERT ZWEBEN** was elected to the Office of City Attorney of the City of  
17 Albany for a term of one (1) year.  
18

19 Pursuant to the State Education Code, Section 10515 the Albany Unified School  
20 District cancelled its election, as only three (3) people took out papers for three (3) seats.

21 The Albany Board of Education appointed the following three (3) people to the  
22 Board of Education:

24 **PAUL BLACK** was appointed to the Office of Board of Education for a term of  
25 four (4) years; and

26 **JONATHAN KNIGHT** was appointed to the Office of Board of Education for a  
27 term of four (4) years; and
