**Subject:** Opposition to marijuana store on Solano Avenue

Mr. Bond - I am writing in opposition to the proposed permit for a marijuana store on Solano Avenue and I would like my comments to be part of the record. I would also like a written answer to questions #2, #3, #5, and #6 below.

- (1) as Albany residents and parents we feel a pot dispensary belongs in the industrial areas along the freeway or on San Pablo Avenue. A marijuana store for is not appropriate use for a residential area that is a primary route for kids getting to/from school and for families walking from West Albany across San Pablo (sidewalks on upper Washington Ave are blocked with parked cars)
- (2) according to the city staff report the Oceanview Elementary playground is within 1,000 feet of the storefront, how does that fact alone not prevent this application from going forward?

The site may or may not meet the requirements for proximity to a school and to a residential-zoned area, but this betrays a lack of understanding of how this street is used. Kids do not generally walk to school along San Pablo, but they do walk to/from Oceanview and Cornell elementary schools using this block of Solano.

- (3) there is no equivalent of an "open container" law for marijuana in Albany. Given that the use permit will prohibit on-site consumption I believe that once outside of the premises customers will choose to partake of their purchases. How does the city plan to control public use outside of the facility? What ordinances are potentially applicable?
- (4) there is already a dispensary on Pierce (East Bay Patients Association), across from Ranch 99 Market, 1.0 miles by car from this proposed new location. I believe public transit provides access to the existing location on Pierce street for someone who cannot walk, bicycle, or drive. Why does Albany need to site another outlet just a mile away?

This reminds me of a similar situation back around 2006 where a resident had to point out to the city that approving a permit for a new bar across from the bowling alley would exceed densities for liquor outlets allowed by the Alcoholic Beverages Commission. It is the job of city staff to know the facts and, where feasible, to implement the preferences of Albany residents and taxpayers. We feel the staff and zoning commission will be abdicating it's responsibility to residents if this permit is approved.

- (5) since members of the zoning commission are individually appointed by the city council <u>I would like</u> to know which P&Z commissioner was appointed by which city council member so we can hold our council members accountable for their appointees actions next election day, November 2nd.
- (6) what justification is there for asserting that the store will have about 250 clients total? Was there any analysis done, or are we just accepting the applicant's statement? Does the city have any control over pricing or other incentives the owners may provide to boost their sales volumes?

I am extremely distressed to find this application has reached this stage with no apparent effort to reach out broadly to affected residents in West Albany. Albany is a small town in the middle of big cities, we want our city government to work to keep it that way and not prioritize revenue generation above quality of life for residents.

I reviewed the Traffic Management Plan from 1998 and I do believe the ADT has increased in the past 12 years. I disagree with that this project is exempt from CEQA review. I know that San Pablo is officially a State Highway and may be impacted by more traffic. The Negative Dec for this project was signed off in 2008. Did Caltrans D4 comment on the Neg Dec?

I am curious as to what is the level of LOS at the corner of Solano and San Pablo? The numbers that were used in the 1998 Traffic Mgmt Plan used for this project were collected in 1996.

The dispensary is only a few feet located outside of the area of a school and where children will be. I want a current Traffic Study done for this neighborhood, Area 1 before this project moves forward.

#### Dear Mr. Bond,

Last night, the proposed site of a medical marijuana dispensary at 1019 Solano Avenue came to our attention. While we are not against the idea of medical marijuana, along with many of our highly concerned neighbors, we are very much AGAINST the location of a dispensary in a residential neighborhood which is densely populated with children and teens walking to and from multiple schools, family oriented community centers (such as the YMCA), churches, restaurants, etc. Not only is there an inherent problem with increased crime due to the nature of marijuana being an illicit drug, issues such as traffic safety and congestion, exposure to second hand smoke, the location of the dispensary in proximity of two alcohol and tobacco retailers, and multiple nearby bars which have very long, well known records of patrons committing drunken disorderliness and other crimes provide STRONG ARGUMENT AGAINST locating such a business in this residential neighborhood. If

marijuana is to be used medically, then it should be dispensed at medical facility in or near, for example, a hospital, just like any other controlled drug! Dear Mr. Bond,

I'm writing to you in opposition of the plan to allow VitaGen to open a marijuana dispensary at 1019 Solano. I purchased my home on the 800 block of Madison twelve years ago. I lived in the apartments on the corner of Solano and Madison from 1996 to 1998. Prior to that I rented a home on the 900 block of Madison for two years.

I feel that we can find a better spot for pot in Albany that can both honor our residential communities as well as provide a dispensary to those in Albany whose well being would be enhanced by a marijuana dispensary within our city's boarders.

I oppose the site for the following reasons:

- 1. The law states that the dispensary should not be within 1,000 feet of a school or playground. Ocean View School playground is within that range and the school is just outside the border. The preschool/MacGregor school is just on the edge as well. The intent of the law is to protect our children from their proximity to a marijuana dispensary. Clearly, both locations are within the range to make such a location questionable.
- 2. The law also states that the marijuana dispensaries should not be permitted within 1000 feet of any "youth-oriented establishment." The YMCA is about 800 feet from the proposed site clearly violating the intent and the letter of the law.
- 3. The proposed location is a highly traveled route for minors. On Monday, October 11<sup>th</sup>, my neighbor did a quick count. Between the hours of 7:30 and 8:30, 54 kids walked or rode their bike through the 1000 block of Solano and an additional 14 (or more) were in the very immediate vicinity.
- 4. The area adjacent to the proposed location is clearly residential. Out of the eleven structures within a one hundred feet radius, only two are commercial properties. The staff were in error to redraw the map as "Solano Commercial".
- 5. The Albany staff have noted that there is a potential for Public Nuisance of people smoking and hanging out near the site.
- 6. The Albany staff also report that "No matter the quality of the operation, dispensaries are targets for serious crimes."
- 7. Albany prides itself as being pedestrian and biking safe. I bike and walk with my children almost everyone and rarely use my car. If people have to reroute their walking and biking travel to avoid lower Solano, this will have a negative impact on Albany's "Green" vision.

I have been a resident of this neighborhood in Albany for 16 years. My wife and I have a 10 month old girl and a four and a half year old boy. We would all be within 300 feet of the proposed location. Over the years, I have been active in revitalizing this area of Albany. An Albany staff person has even called the 800 blocks and 900 blocks of Madison the "Poster Child Blocks" of Albany for our organized activities which include annual block parties, tree plantings, movie nights and informal neighborhood watch programs. All of these family activities occur within 500 feet of this location. I am concerned that marijuana distribution so close to home would undo

much of this neighborhood development and revitalization. It's hard to imagine that it would not change the character and sense of place we proudly call home.

I look forward to the day when my son and daughter can venture safely off our block and visit friends across the street or walk or ride their bikes to school on their own. I can't imagine anyone attending this meeting, who had children living so close to such a facility would not share our concerns. Can't we as a community find a better spot for pot?

Dear Jeff.

I am doing my best to reschedule a prior commitment for this evening so that I can attend this very important P&Z meeting. In case I am not successful, I want to make sure that you know my feelings on the proposal of putting a marijuana dispensary on the 1000 block of Solano Avenue.

This location is smack in the middle of a residential area and should not be allowed. People live next door, behind, above and across the street from this retail location. I see young children walking past this location every day on their way to and from school. I walk past this location on my way to and from the bus that I take to work each day. I live on the 800 block of Adams Street and my grand daughters, ages 4 and 7, go right in front of this storefront when they ride their bike and scooter around the block. These activities will no longer be safe and neighbors will be forced to stay indoors or find alternate routes.

I have lived in Albany for over 30 years. My children grew up here and my grandchildren are currently growing up here. When the City rezoned our neighborhood from CE to R3, I was one of the most outspoken proponents of this change. This part of Albany has been slowly moving from business to residential based on the increased number of privately owned residences in the area. It was good that the City recognized this in the rezoning process. I understand the importance of commercial revenue and feel that our neighborhood has obtained a nice informal balance between the business on Solano and San Pablo Avenues and the neighborhoods on Adams, Madison & Jackson Streets. We seem to have worked out the use of parking and foot traffic. But this type of business will tip the scales and, based on what has occurred in other cities, will downgrade our neighborhoods. We are already surrounded by two bars (Club Mallard and the lvy Room), a tattoo parlor (900 San Pablo), a fortune teller (900 San Pablo), and a massage parlor (800 San Pablo).

What will the impact be on the existing businesses on either side of this location? Both the hair salon and the acupuncture businesses have been there for a long time and I would hate to see them forced to leave because of the disruption caused by a marijuana dispensary. I cannot believe that reputable businesses will want to open next door to a marijuana dispensary. Our neighborhood will then continue to decline and become even more unsafe.

I am not against a marijuana dispensary if it truly helps people who are ill, but I am concerned that it be in a location that will not impact or degrade a residential neighborhood. Even the Staff report for Item 6b states: "The two areas of greatest concern are: 1. The potential public nuisance activities associated with patients smoking marijuana in public areas immediately after leaving the dispensary: and, 2. Regardless of the quality of operation, dispensaries have been targets for serious crimes." Why would you want to put this in my neighborhood and jeopardize the safety of me, my family and my neighbors?

There must be other areas that are more conducive to this type of business such as: Cleveland Avenue or the east side of Eastshore. Another possibility might be in the new development planned at UC Village, on the San Pablo side. There are no other areas that I can think of where residential neighborhoods would not be greatly impacted. Another option would be to locate this business in the City offices. I understand that this proposal was rejected when the new offices were being built and redesigned. This causes concern for me because, if our police officers, fire fighters and City leaders do not want to deal with the type of disruption that would be caused by a business of this type near them, why do they feel it is good for it to be near resident's homes.

I urge the Planning & Zoning Commission to not follow staff recommendation. Please do not approve the request for a conditional use permit for a marijuana dispensary at 1019 Solano Avenue location.

#### Dear Mr. Bond:

My kids go to Cornell Elementary school and we live close to Ocean View school. We pass in front of 1019 Solano Ave. at least twice a day: one in the morning, around 8am, the other one in the afternoon, around 3:15pm, and I was concerned in learning this morning about the proposed site for a marijuana dispensary.

I read the comments posted in the link and I agree with most of them: **this is a kids' route** to go to school: to go to Ocean View, to go to Cornell, to go to MacGregor. My main fear is that the proposed location is not the proper one, and considering the potential nuisance activities associated with a dispensary in a heavily transited zone, it will be detrimental for our kids' safety.

Please also take into account the following arguments:

### The Applicants Do Not Meet the Findings Required by Subsection 20.100.030.(D) of AMC.

Pursuant to Subsection 20.100.030 (D) of AMC before granting an approval, adverse impacts should be considered, and the proposed use of the subject property "will not be detrimental to the health, safety, convenience, or general welfare of persons residing or working in the vicinity, or physically injurious to property, improvements or potential development in the vicinity, with respect to aspects including **but not limited** to the following..." (emphasis added).

The proposed site is dangerously close to five facilities with children: Ocean View Elementary School, MacGregor School, Cornell Elementary School, AlbanyYMCA (after care program) and Chinese School (after care program). Moreover, Solano Avenue is a major avenue in the city, and many kids and families, like mine, walk in front of the proposed site every morning and every afternoon. The proposed site and the proposed hours (8am - 7pm) are inconvenient for Albany kids. For that reason, the Commission should not approve that location.

#### The Applicants Do Not Meet the Findings Required for a Medical Marijuana Dispensary under Subsection 20.20.110 of AMC.

Pursuant to Subsection 20.100.030 (E) of AMC "No medical marijuana dispensary shall be located within a one thousand (1,000) feet distance of any of the following:

... b. Any schools, child care centers, public libraries or public community centers (.)"

Planning and Zoning Staff Report shows that the proposed location of the medical marijuana dispensary is 998 feet, with a margin of error of 30 feet. (See Staff Report, pp. 3-4, "The distance from the entrance of the dispensary to the closest fenced corner of the school grounds is 998 feet.")

The Code is clear: there is no distintion about the entrance of the dispensary, or the entrance of the school, but the distance between a child-user facility and a dispensary.

The distance is clear: 998 feet, i.e. within 1000 feet of the proposed location. Moreover, the regulation of medical marijuana dispensaries in the City of Albany is very restrictive, in order to "promote the health, safety, morals, and general welfare of the residents and business within the city." The Commission should not approve the proposed location because it will entail an unwarranted variance to the applicants.

I understand the needs of other Albany citizens, but that is not the proper site for a medical marijuana dispensary. Thus, I highly discourage the proposed site and I request the Planning and Zoning Commission to deny the proposed site for a medical marijuana dispensary.

Hello,

I am a mother of a 5 year old and an 11 year old, living on Adams Street, between Solano and Buchanan. I am sure you have received several emails today regarding the proposed medical marijuana dispensary. However, I imagine that given more time, more notice, you would have received many more. It is only yesterday that I was informed by a neighbor of the plan. I will attend this evening's meeting. I am sure that I am reiterating what you have heard already - this is not the right location!

I have never in my life known, let alone lived in, an area so condensed with children. Albany has become an unusual town - one that has attracted many families due to the wonderful school system, families who in turn participate in continuing to ensure that the schools as good as they are by volunteering, contributing, and putting children's education and welfare at a high level of importance. Because of this, Albany has a sense of being a small town (within a small city) where many of us parents allow our children to walk to and from school or parks, because we have a sense of safety in the community we have created. It is also a community trying to be more pedestrianized.

Despite this, the children in this particular neighborhood do have to contend with several issues due to being so close to San Pablo Avenue (and perhaps even more to do with being on the 'other' side of it). My 11 year old son crosses San Pablo Avenue and sometimes the place he and his friends purchase candy happens to be the liquor store on the corner. There are a few homeless people around, and one middle aged woman who is bi-polar. These are familiar unwanted attributes to what is otherwise a delightful, wonderful neighborhood. As I walk my 5 year old to kindergarten every morning, we run into several families that we know, and pass more that we don't.

It seems to me that the addition of this type of facility will have an enormous impact on the safety, traffic, and overall feeling of the neighborhood. Some families will stop allowing their children to walk. Many children will be out, exposed to this. I believe that people have the right to pain management. I also understand that there are plenty of people who obtain licences for medical marijuana that use it for recreational use. What about the older kids, the older middle schoolers, for example, who walk by. Perhaps they will be able to purchase some marijuana from a client who wants to make a little money on the side. There are several scenarios, not unlikely ones, that tell me again, this is simply not the right location!

I understand that this may bring in some needed revenue for the city. I also understand that these facilities probably run into opposition wherever they attempt to locate. However, i simply can't think of a worse place to put this than in such a densely packed area, predominantly with families of younger children.

I am extremely concerned about this. I truly hope that tonight's meeting will lead to the correct decision - find another location.

Dear Mr. Bond,

I am writing to express my dismay at 1019 Solano Avenue as the proposed location for Albany's medical marijuana dispensary. I fully support having a dispensary in Albany, with the benefits to both residents with medical need, and the additional tax revenue that a dispensary could bring to the city. But I believe that the location and the speed with which the Planning and Zoning Commission plans to vote on the dispensary approval should be reconsidered. In my opinion, the proposed location has three issues that need to be addressed before approving such a project.

First and foremost, as a resident of the block three doors from the proposed location and parent of two elementary school children, I am concerned for the safety of our children and potential exposure to marijuana smoke. We walk that sidewalk three round-trips a day with our 5 and 7 year olds, and we are not alone. We counted the number of children that walked either in both directions on Monday and had about 70 kids going to preschool, elementary school, middle school and high school between the hours of 8 and 9:30. This coincides with the proposed hours of operation of the dispensary. The 11 hour schedule 7 days a week will surely lead to increased traffic which also impacts potential safety of our children at the various crosswalks. Additionally, reading about and talking to people who have used dispensaries in neighboring cities, I believe that there will be increased loitering or "hanging out" outside of the store that appears to go hand-in-hand with people smoking the marijuana they just acquired inside. Has Albany had internal discussions on these points that we residents have not been made aware of?

Second, the proposed location has several issues that seem at odds with the city ordinance on dispensaries. I believe by City of Albany's own assessment of the location, it is just under 1000 feet to Oceanview Elementary School. And while there is a margin of error with the distance as measured by GPS, that means that the school is too close to the proposed location. Additionally, the YMCA hosts a childcare facility and is approximately 800 feet from the proposed location, and the preschool at the ex-MacGregor High location appears to fall within 1000 feet of the proposed location. And while some city documents indicate 1019 Solano as Solano Commercial, the city's records also show it as "light residential". These are all factors that should be deliberated and the discrepancy in the city's own records should be reconciled before any vote by the Planning and Zoning Commission.

Third, the speed with which the proposed vote by the Planning and Zoning Commission is inconsistent with the typical Albany process of thoughtful and open deliberation. As an immediate neighbor, we had the less than two weeks notice of the proposed use before today's planned vote. This does not give us the appropriate time needed to research the experiences that other cities have had with similarly located dispensaries (in majority residential neighborhoods), discuss the other potential locations (it seems that San Pablo Avenue or Cleveland Avenue would be more appropriate), and talk to the people who will be most impacted – we the residents and parents of the neighborhood.

Chief McQuiston;

Albany's medical marijuana dispensaries ordinance provides that marijuana may be dispensed to Alameda County residents who "hold identification cards issued by an entity whose procedures for validation and issuance have been approved by the Albany Chief of Police." Can you clarify the criteria that you will employ to qualify the issuing entities. I believe that the only card that meets the requirements of State law (H&S Code §§ 11362.7-11362.83) is the card issued by the County. The ID card plays a critical role in assuring that patients are property qualified. The card should also enable the City to assure that Albany's ordinance limitation of cliental to Alameda County residents is observed.

I think that a clear understanding of the procedure that will be followed by your Department in approving the ID cards is critical to the City's understanding of the current marijuana dispensary application being considered by the City.

To The City of Albany Planning and Zoning Commission,

We are writing because we do not want a marijuana dispensary on Solano Avenue.

Our kids (we have 4 children) walk or ride bikes through this block of Solano Avenue daily. Our one son walks this way to get back and forth to school every day. This route includes the Middle School students and the Albany Y who walks kids in this block to go back and forth from OceanView Elementary and to Kids' Club as well. Many other families simply use this area while enjoying walks in the neighborhood or to get to the amenities we all love further up on Solano. We have other concerns including parking and traffic, but I think for many of us we can't get past the fact that this is a main route for minors walking to and from school. Most of us would love for our kids to walk or ride their bikes on their own when they are old enough and we want to feel comfortable that this is a safe route. Having a dispensary on Solano Avenue no longer makes it a safe place or route for any child.

Your own reports state that:

"Staff has consulted with planners in nearby communities regarding the operation of medical marijuana dispensaries. Many dispensaries have operated in a manner that serves the community and are compatible with their settting. There are, however, serious considerations to the location of a dispensary. The two areas of greatest concern are:

- -The potential public nuisance activities associated with patients smoking marijuana in the public areas immediately after leaving the dispensary; and
- -Regardless of the quality of operation, dispensaries have been targets for serious crimes."

We have not heard an argument that those in pain should not have access to medical marijuana, just that the dispensary should not be located in such a residential neighborhood. There is currently another company wanting to obtain a permit on San Pablo Avenue but that is on hold until a decision is made on the Solano location. We would favor a location on San Pablo where there is not the concentration of kids going by multiple times a day. We just would like you to choose a better location.

Please seriously consider our letter and help our children be safe by not putting a marijuana dispensary on Solano Ave.

I am a 10 year resident and home owner on the 800 block of Madison St. and I am strongly against having a marijuana dispensary in what is essentially a residential neighborhood. There are a growing number of us in the area that feel this way and we are organizing to protest its establishment. We will be at the planning and zoning meeting this evening to express our disapproval. Here are a few of our reasons:

- \* That corridor of Solano is a major thoroughfare for students, a number of whom are unaccompanied, walking to and from Albany's schools each morning and afternoon. Yesterday we counted around 75 children between 7:30 and 8:30 AM.
- \* There is a lot of concern over spillover effects of having a quasi-legal drug facility in the area. Examples of this would be increased crime, loitering, public consumption of marijuana, etc. and the lowered quality of life and the likely reduced value of property that would follow such activity.
- \* The site is legally questionable with regard to the relevant Albany ordinance: it is less than 1000 feet from the Ocean View playground. It is also less than 800 feet from the Albany YMCA which provides youth-oriented activities as well as child care. The ordinance states that a dispensary must be over 1000 feet away from public schools, parks, playgrounds or youth-oriented facilities.

Many of us strongly believe that if Albany is to establish a dispensary it should be located in the industrially zoned areas near the highway as the current zoning restrictions for a dispensary would likely make it difficult to have it anywhere on Solano or San Pablo.

Where do you stand on this issue? We hope you will give us your support.

#### Dear Mr. Bond-

I'm writing in opposition to the proposal to open a marijuana dispensary at 1019 Solano Ave. My family and I have lived in the community for years, just around the corner from the proposed site. I pass by there four times a day as I walk to and from work on Solano Ave. and my four children frequently walk, bike and scooter passed the proposed site.

I'm in opposition for the following reasons:

- 1) The law states that any dispensary shall not be within 1000 feet of a public school, child daycare center or public community center. While the site may be 1000 feet from the front door of Ocean View school, it is not 1000 from the playground/park area. This seems a clear breach of the guidelines stipulated by the city.
- 2) The YMCA, where children frequently gather, is also within 1000 feet of the establishment.
- 3) The law states that the medical marijuana dispensary shall not be located within 1000 feet of any business that caters to minors or who's patrons are primarily minors. Dave's Dugout (baseball card shop) is well within 1000 feet of the proposed site.
- 4) If the intent of the law is to protect children from contact with such a site, it ought to be taken into consideration that large numbers of children pass by the site daily on their way to and from school and that the dispensary would open open during the hours when they pass by. One resident counted 70 children pass by on a typical school morning.
- 5) The law states that the principle entry to a dispensary shall not be within 25 feet of any residential entrance, including the principle entry of any multi-unit residential building. The entrance to the adjacent apartment building is well within the 25 feet range.
- 6) The law states that there shall be no sale of any product, good or service not associated with the sale of marijuana but the VitalGen plan seems to include other services in addition to the sale of marijuana (Yoga?).
- 7) There are a high number of residencies surround the two commercial properties in that are such that the same reasons a dispensary would be disallowed in a strictly residential area could be applied here.
- 8) As the staff has acknowledged, there will likely be an increase in crime in the area if the dispensary is opened. None of the home-owners in this area, all of whom have been hit by the economic downturn, can afford another such depreciation in home value.
- 9) I have yet to speak with one resident who is for the proposal and the many who are against it seem to be strongly opposed.

While the effort to show compassion to those in need of medical assistance is good, the overall needs of the community ought to be considered as well. The vote of the citizens allows for the presence of a dispensary but does not mandate it. Therefore, we should move forward on establishing one only when it is a win/win proposition. The 1019 Solano Ave. proposal does not meet this requirement. I hope the committee will take into consideration these facts and the number of residents who seem to be opposed to it.

I was recently made aware of an application to the city to open a marijuana dispensary on Solano. I would like to say that while I am not opposed to marijuana dispensaries in general, I am opposed to them being located in residential neighborhoods. Especially on a street that is used by children and youth as they make their way to school.

As with any business moving into a largely residential area there are issues that arise relating to increased traffic, crime, and parking. With regards to traffic, many Albany children walk or bike to and from school. Increased traffic in this area may lead to an increased pedestrian injuries (introducing more cars into the equation) and long lines of traffic around the Jackson Street stop signs or Solano/San Pablo traffic light. Parking is already an issue given that many residents park their cars on the street rather than in their garage (which for many people is impossible given the relative size of the garage compared to a car). My name is Christy Baty. I am an Albany resident and parent of two girls who attend OceanView Elementary School.

I have recently learned about the proposed Solano ave location of the Wellness clinic/Marijuana dispensary and I would like to express my very strong reservations about that location.

My girls, as well as a large walking group in which several families participate, walk down Solano to get to and from school. This is an organized group that we have participated in for the past several years. In addition to our group, I see families and children walk along that path (Solano between Adams and Madison) every day. This is a main thoroughfare for minors. So much so that there used to be crossing guard at Solano and San Pablo (though, sadly, that position was cut in budget considerations last year), there is also a crossing guard at Solano and Jackson.

I understand there was a traffic study conducted by the Albany Police Department that will also attest to the fact this is a major thoroughfare for school children.

My concern is the location. Having a dispensary located along this route, during school hours, is objectionable. I don't have a problem with a dispensary, just the location. I understand an alternative location is proposed on San Pablo which would be a perfectly reasonable alternative.

I live next to the proposed site for the medical marijuana dispensary. I am strongly opposed to the idea of allowing a medical marijuana dispensary to operate in a residential neighborhood. These are the major reasons.

## 1. Safety

The corner of Solano and Adams has already been a hotspot for troublemakers who frequent the nearby Ivy League Pub.

You can verify this statement by checking the police complaints. A marijuana dispensary close to the Ivy League and two liquor stores can lead to major episodes of dangerous and disruptive behavior.

Moreover, children walk or bike through this block.

Allowing this business to operate attracts dangerous people into the neighborhood and puts our children at risk.

# Dear Superintendent Stephenson:

I am writing to you as a concerned parent regarding a current issue in Albany.

As you may or may not be aware, a medical marijuana dispensary has applied to open a storefront at 1019 Solano Avenue. This is the block of Solano two blocks west of San Pablo Ave and is in our residential neighborhood.

I have one school-age child who attends Cornell Elementary and two more children who will enroll in Cornell in the coming years. I walk this stretch of Solano every day to take my child to and from school.

The street is a main thoroughfare for our community's school children. Students from our neighborhood funnel to Solano to walk to Cornell, Ocean View, the Middle School, and the High School right past the proposed dispensary location. The YMCA uses this route to walk their Kid's Club members to and from Ocean View before and after school. This represents a countless number of children. It brims with life and a sense of community - and the feeling that it is a safe corridor for our school children to walk.

Indeed, one of the things I love best about Albany is walking my children to and from school. Albany prides itself on its walkability and encourages students to walk with such events as last week's walk-to-school day.

However, I have serious concerns about walking my children past a medical marijuana clinic, which will open at 8 in the morning and close at 7 in the evening. Albany staff has recommended that the Planning Commission approve the use permit for the clinic. However, in their own document they state the following:

"Staff has consulted with planners in nearby communities regarding the

operation of medical marijuana dispensaries. Many dispensaries have operated in a manner that serves the community and are compatible with their settting. There are, however, serious considerations to the location of a dispensary. The two areas of greatest concern are:

- -The potential public nuisance activities associated with patients smoking marijuana in the public areas immediately after leaving the dispensary; and
- -Regardless of the quality of operation, dispensaries have been targets for serious crimes.

I believe there is a more suitable location in Albany that is not in a residential neighborhood and most importantly <u>is not on a main thoroughfare for children</u> walking to and from school.

I am attaching the staff report so that you can review this information for yourself. As you will see marijuana dispensaries are required to be 1,000 feet from a school. The staff measurements show that Ocean View Elementary is 1,072 feet measured to the front door and 998 feet measured to the fenced corner of the playground.

Given the number of students in your district that this affects I wanted to express my concern to you. I want Albany to remain a safe, community where I feel comfortable walking my children to school and when they are old enough I feel safe allowing them to walk to school without adult supervision. However, if I know that they are walking by a dispensary that draws potential crime and people smoking pot as the staff report points out I think my feeling of safety would be seriously compromised.

I urge you to please look into this issue. This came to my attention only last week and most neighbors I speak with are not yet aware of this potential change to our neighborhood. However, I can say every parent I have spoke with is just as concerned as I am.

There is a planning and zoning commission meeting this Tuesday, October 12th at 7:30 p.m. to decide upon this issue.

Given that this is a timely issue I would appreciate your acknowledgement that you are looking into it further to consider the impact on the district's students.

Please do not rush into permitting a marijuana dispensary in Albany. Even though the residents narrowly voted to approve a dispensary in our city, you must wait for the right location to open up. In my opinion, the right location would be the frontage road through west Albany, or perhaps in the Alta Bates Medical center on San Pablo. Please continue the search for the right location and do not approve this proposed location.
