RE: Final Decision Regarding Dispensary at 1019 Solano Avenue -- DEFER ACTION

Dear Mayor and City Councilmembers:

I represent Zo Collective Cafe and its Executive Director, Harry Houngviengkham. We request that the City Council delay consideration of a conditional use permit for a proposed medical marijuana dispensary (MMD) at 1019 Solano Avenue, which we understand is scheduled at your January 10, 2011 meeting. We urge you to defer such a decision until our application for a MMD at 745-747 San Pablo Avenue, named "Zo Collective Cafe," has been reviewed by the Planning & Zoning Commission. As we understand the process, the City of Albany is to select one MMD from among candidate applications. The consideration of our application has been delayed due to its mistaken disqualification, which the City has recently corrected.

As confirmed in the attached letter from the Police Chief Michael McQuiston (dated November 5, 2010), Zo Collective Cafe has been *approved* for purposes of compliance with the City's Business License Background Investigation as required under provisions of the Albany Municipal Code governing establishment of a MMD in Albany. It is in City's interests, and it is only fair, to compare the relative merits of each MMD application, which can only be accomplished after the Planning & Zoning Commission has had an opportunity to consider the issue and take action with respect to Zo Collective Cafe's application.


We request that the City Council defer consideration of the application presently before it until the Planning & Zoning Commission has approved or denied the application by Zo Collective Cafe.

I have revisited my previous rejection of your application to operate a marijuana dispensary within the city of Albany and, based on additional information and advice of legal counsel, your application is hereby *approved* for purposes of compliance with the Business License Background Investigation required under Albany Municipal Code 20.20.110.

This is not a permit to conduct marijuana dispensary activity in the City of Albany.
