8-2. Public Improvement Grant and Cooperation Agreement (File #670-20)

Mayor Javandel and Council Member Thomsen recused themselves due to a conflict and left the podium. Vice-Mayor Atkinson took over chairing the meeting.

The City Manager reported that the City adopted the Cleveland Avenue/Eastshore Highway Redevelopment Plan in 1998. The principal goals of the implementation plan are the elimination of blighted conditions and the promotion of development and improvements to strengthen the economic base of the community.

The purpose of the agenda item before Council is to enter into a Public Improvements Grant and Cooperation Agreement with the Albany Community Reinvestment Agency (ACRA). Through this agreement, the ACRA shall pay for designated portions of, and the City shall conduct public improvement projects, to alleviate blighting conditions in the Project Area.

This includes improvements to Cleveland Avenue and the acquisition of a 4.5 acre property on Pierce Street from the California Department of Transportation (Caltrans), development of the property and associated improvements.

A summary of the Council comments is as follows: This proposal has been in the planning stages for over 20 years and due to proposed State action the City decided to go ahead with the action as soon as possible.

8-3. Purchase and Sale Agreement – Acquisition of 4.5 acre adjacent to Cleveland Avenue and Pierce Street

(File #600-30)

The negotiations between the City and CalTrans regarding the acquisition of the Pierce Street parcel have resulted in a proposed Purchase Agreement at a cost of \$1,950,000. The City is also currently negotiating an airspace lease for contiguous parcel beneath the freeway on Cleveland Avenue, to be used for storage and parking of reserve vehicles.

The acquisition of the Pierce Street parcel as a location for the City's Maintenance Center, an adjoining neighborhood park, a bicycle trail connection between the Bay Trail and the Ohlone Greenway and other potential uses, has been identified in the Five-Year Implementation Plan for the City of Albany Reinvestment Agency and is crucial to economic development in the City.

The following people spoke: Allan Maris, Albany resident; Joan Larson, Albany resident; Jacqueline Armstrong, Albany resident.

A summary of comments is as follows: Questions were asked about the cost and concern expressed about the lack of signage. It was stated that the new maintenance building should be environmentally friendly, efficient and that it fit into the Spanish stucco design to enhance that part of the Cit. It was asked whether signage could be placed at this area regarding the historical relevance.
