### 7. UNFINISHED BUSINESS

**7-1.** Notice of Completion – Lower Codornices Creek Project (File #600-30)

The Assistant City Manager reported that the Lower Codornices Creek Restoration, Phase 3, Step 2 to complete the restoration of the creek between 6<sup>th</sup> and 8<sup>th</sup> Streets and the construction of a Class I bicycle/pedestrian trail along this segment. The project was awarded to William P. Young Construction.

It was noted that the project did not involve any City general funds, as a \$2.1 million grant from the California Resources Agency River Parkways Grant Program for the  $6^{th}$  - 8th Street segment. The Project Manager gave a power point presentation on the project.

Council Member Thomsen presented Resolution No. 2011-8 – A Resolution of the Albany City Council Approving and Accepting Improvements and Directing the Filing of the Notice of Completion for Contract No. C10-2, Lower Codornices Creek Restoration, Step 2, Phase 3.

#### 8. NEW BUSINESS

## **8-1.** BART-Albany License Agreement – Ohlone Greenway (File #600-40)

The Community Development Director reported that in 1970, BART and the City entered into a Landscaping Agreement. The Agreement addressed BART's construction of landscaping and other improvements located beneath the aerial structure and that the City would maintain those improvements.

Although there is no expiration date, it appears it only applies to the area between the Albany/Berkeley City limits and Solano Avenue. For this reason, both BART and the City concur that a new License Agreement is needed, which would apply only to the BART-owned premises.

Council Member Atkinson asked whether should recuse herself, as she lives across from the BART tracks. The City Attorney stated that he believes it would be wise decision to recuse herself.

At this time, Council Member Atkinson left the Council Chamber. The Public Works Manager spoke to a question regarding the lighting at this area. It was noted that when the construction is completed there will be lighting, however, not LED but 100 watts, which are very efficient.

Mayor Javandel asked if anyone would like to speak and the following people spoke: Thelma Rubin, Albany resident; Sue Schaffer, BART representative.

A summary of the comments is as follows: Asked if BART would allow paintings of big animals on the columns, which has been done in other areas. BART representative responded that this could not be done at this location, as a lot of work is performed on the columns and the paintings would be taken out.

#### **MOTION:**

Moved by Council Member Thomsen, seconded by Council Member Wile to approve a License Agreement between the City of Albany and the San Francisco Bay Area Rapid Transit District (BART) regarding maintenance and use of the BART-owned portion of the Ohlone Greenway.

## 8-2. Financial Statements and Projections

(File #330-50)

The Finance Director reported that the 2010-11 budgets projected a net excess of revenues and transfers-in over expenditures and transfers-out of \$12,063 and the projection for the full fiscal year is for a net excess of revenues and transfers-in over expenditures and transfers-out of \$14,781. The favorable projection is attributed to savings in personnel costs. Revenues are projected at \$13,075,720, which is \$487,450 below the budget and expenditures are projected at \$16,299,237, which is \$490,168 below the budget. The "bottom line" increase to the General Fund, fund balance is \$14,781.

Mayor Javandel asked if anyone would like to speak and the following person spoke: Ann Foreman, Albany resident.

A summary of the comments is as follows: It was suggested that the Council set up a fiscal task force made up of Albany residents and spoke about employee salaries and benefits.

A summary of the Council comments is as follows: Expressed concern about the Police and Fire overtime budget. It was noted that the revenues from the racetrack are down and suggested that the City send a letter to the Legislatures regarding increasing the handle, which has not been done in 75 years. It was suggested that a dedicated traffic officer would be a good idea and maybe when the City is in a better fiscal position it would be possible to have this. It was noted that they would like some way to enforce traffic rules and suggested that the Traffic & Safety Commission look at the issue of a red light camera program.

The City Manager thanked the Department Heads and staff for coming up with creative ways of saving money and noted that she would like to have a study session with the Council and the public to discuss the budget.

No action taken on this item.

## **8-3.** Opposition to Legislation regarding Abolishing Redevelopment Agencies (File #660-40)

The City Manager reported that as part of the development of the State of California's fiscal year 2011-12 budget, the Governor has proposed abolishing local redevelopment agencies effective July 1, 2011. The City has a redevelopment agency and currently receives approximately \$500,000 a year in redevelopment tax increment revenue. Under the Governor's proposal, the City could lose close to \$400,000 per year in tax revenue.

It was noted that before Council is Resolution No. 2011-9, which opposes the abolishment of redevelopment agencies in California.

A summary of the comments from the Council is as follows: Believe that more information is needed before any action can be taken by the City Council and could not support Resolution No. 2011-9 at this time. Another point of view was expressed noting that support would be given to Resolution No. 2011-9.

## 8-3. Opposition to Legislation regarding Abolishing Redevelopment Agencies

The City Manager suggested that the Resolution come back to Council with language more specific to Albany, that monies come back to local control or spent on local school districts and support the idea of a ballot measure for revenue enhancements.

# 9. OTHER BUSINESS, REPORTS ON MEETINGS ATTENDED, ANNOUNCEMENT OF EVENTS/FUTURE AGENDA ITEMS

Council Member Lieber stated that he is the City's representative on ACAP, which is experiencing serious personnel issues at this time.

Mayor Javandel announced that the meeting would be adjourned in memory of Evan Flavell and a moment silence observed.
