6-1. CAP Implementation – Staff Update

Almaguer provided a brief update. Energy efficiency rebates for commercial and residential should launch in February. Reports from audits for solar and energy efficiency upgrades on city buildings should be received within the month. Staff continues to work on the RECO concept and is working to identify triggers for RECO requirements including remodels, point of sale, or other. Assistance is being provided by consultants that are also working with the City of Hayward to develop a RECO.
