Re: Artistic Bike Racks in Albany – Information Item

The Traffic and Safety Commission is currently in the process of recommending the Active Transportation Plan for environmental work to the City Council in the upcoming meeting of May 26, 2011. In doing so, the commission would like to include the flexibility to install artistic bike racks similar to the ones attached as a possibility for special locations, such as parks and public buildings (or private development if owner desires). These racks would be an addition to the standard inverted U design that is more commonly used on the City's streets and is included in the Draft Active Transportation Plan.

The Commission would like to inform the Arts Committee of the fact that this concept would be presented in the Draft Active Transportation Plan for City Council consideration. Because of the nature of this artistic bike racks, the Arts Committee review will be sought prior to any implementation.
