Thank you for the opportunity to submit this proposal to provide consulting assistance to the City of Albany. We understand the City has recently been approached by the owners of the Golden Gate Fields Racetrack property in Albany and Berkeley regarding the possible future re-use of this site for an additional campus for the Lawrence Berkeley National Laboratory. As such, you have indicated a need for assistance with developing revenue sharing and protection alternatives and associated discussions with the property owners, the City of Berkeley, the Albany Unified School District, and any other related parties as needed.
