STAFF RECOMMENDATION

That the Arts Committee discuss the restoration and possible relocation of Herons.

BACKGROUND

The Herons sculpture was created by Mark Canepa in 1999 at a cost of \$10,000. Over the years, the sculpture has deteriorated and has been vandalized with graffiti. The Arts Committee contacted the artist to discuss restoration ideas. Attached is the current proposal from the artist which includes the removal of the sculpture, restoration and installation.

At its July 2011 meeting, the Arts Committee made a motion to investigate the feasibility of moving Herons to a site at City Hall. Attached is a rendering created by Committee Member Adame of Herons at the City Hall site. The group of three herons is 10.5 feet tall and about 10 feet wide. The circle at City Hall is 12 feet wide including a one foot brick border.

Staff identified other possible sites for Herons as identified in the Public Arts Master Plan for discussion by the Committee. Alternative sites include other locations around City Hall, Memorial Park, Key Route and the traffic Islands at Peralta/Ordway and Posen. Pictures of some of these other sites will be provided at the September meeting.

FISCAL IMPACT

Percent-for-the-Art funding would be used to pay for this project. The total cost for the restoration of Herons is estimated at approximately \$6,250.00 and does not include the cost of pouring cement at the new site.

Dear Albany Art Commission,

The first phase of the project is removal and transportation back to MC Artworks Studio. This will be time donated and all costs incurred will be done by MC Artworks and staff. The removal of the herons and plaque will be done with acetylene torches and transported to MC Artworks studio.

Second phase consists of bringing sculptures to Poly Engineering for powder coat REMOVAL. The plaque will go to the foundry for cleaning and repair. These costs will be reflected in total price for repowder coating at Poly Engineering in Richmond, CA.

Third phase will include cutting and replacing all rusted out metal of the exterior of the metal herons. The shape and size will still be almost exact and the choice of colors will be presented to the commission. If the colors are in stock the price will be less. If ordered, there will be a price charged. Fourth phase will be re-installation and overseeing of said project.

First phase

- No charge

Second phase

- The burn off process of powder coating by Poly Engineering at the cost of \$1,000 for ALL 3 herons.
- Cleaning and refurbishing of bronze plague approx. \$150

Third phase

- Labor (cutting & removal of all rust spots, replacement pieces & welding/grinding preparing for NEW powder coat) \$900
- New addition to sculptures is a 30" x 40"x 3/8" plate steel base. These will have 4 holes per base and will be designed for new location. \$200 per plate.
- The new powder coating phase is based on color choice and ranges from \$900-\$1200 per heron.

Final Phase

- Re-installation of art piece, MC Artworks will supervise whomever will be chosen to pour cement slab for heron sculpture. All these bids can change without notice and will be adjusted accordingly keeping price down as much as possible.

At this time this is the best estimate pricing I can offer.

Purpose of Show

The photographs proposed for this exhibit were taken in the area surrounding Regent, North Dakota. Regent is located in the south west of the state of North Dakota. It is a small farming community with vast, windy open space that is sparsely populated, and land that is constantly covered with a changing variety of crops. My photographs show a shelter constructed at the turn of the century for travelers and their horses, and an example of an early farmhouse. It is amazing to me that these structures are preserved after all these years, and that the residents of Regent live so close to remnants of their history. I worry about how long these wonderful structures will survive.

Resume

I am a retired architect. I received my Bachelor of Architecture degree from the University of California, Berkeley in 1965. I have exhibited my photography at the Gualala Arts Center in Northern California. That exhibit was my only show, a single black and white photograph of an original, low sheep barn and sheepherder's shack located on the Sea Ranch property. The sheep barn has since been destroyed. I use a simple 35mm single lens reflex camera and Kodak Plus-X film. I have been a student at the Albany Senior Center in Debra Ratner's Memoir Writing Class for many years.

List of Works

All of the photographs will be 11x14 inches, matted, and framed in 17x20 inch black aluminum frames. I have enclosed three 5x7 photographs of the shelter/horse barn and three of the farmhouse. Each photograph is valued at \$300, and has a penciled number indicated on the back. The descriptions are as follows:

- 1. Stone shelter wall with door opening and tree trunk in foreground.
- 2. View through shelter window/door opening of horse barn beyond.
- 3. Detail view of horse barn shingle roof and stonewall.
- 4. Overview of farmhouse with tree in the background.
- 5. Detail view of partially demolished end of the house with interior door opening.
- 6. View out of interior door opening out onto the farmlands.

Also attached is a copy of a poem I wrote describing my feelings about the prairie while in Debra Ratner's class. I propose to have this text graphically enhanced and framed in a manner compatible with the photographs to be part of the exhibit

<u>NOTE</u> This exhibit will also include the photographic work of Howard Hardie. He as traveled with me to North Dakota and his submission will be separate. The graphic format of both of our exhibits will be coordinated and compatible.

If I vanish, it will be to a quiet place, with a steady wind out of the west carrying sweet spring pollen and some dust, wind that bends the tall dry grass, and rattles windowpanes. Where dry summer breezes warp and split the barn boards, and wet winter storms come to flatten them. When rusty nails work loose, I'll hammer them tight again. A three-wire fence keeps you out but leaves me free. It doesn't block the long wide view, yet defines my boundaries. Late in the afternoon I walk, the soft earth easy on my feet, cold air to my face. The sky turns from blue to black. Pinpricks of light won't show the way. A lamp left on in a distant window, guides me back.

Purpose of Show

I am a photographer and educator living in Santa Rosa, California. I was raised in Albany, where my mother and my sister still reside. I attended Marin School. I graduated from the University of California at Berkeley in 1975 with a major in history and received a master degree in history from the University of Minnesota in 1980.

I photograph using traditional approaches with black and white film and silver gelatin prints. I employ medium and larger format cameras. Doing my own darkroom work is an integral part of the creative process where I explore and exercise expressive control over my work

I currently exhibit my work in ARTrails Open Studios in Sonoma County. I have previously exhibited in the Community Center in Santa Rosa.

Jo-Anna Pippen Artist statement

As an artist working toward an unknown inspires me. I began as a painter; I loved the challenge of creating something out of the materials of painting but felt limited by the medium. I expanded my exploration to photography. Through photography I could own an image independent of the studio. It allowed me more flexibility and autonomy without the limits of a confined space. I loved the creative inner visions that painting allowed but found the immediacy of photography more satisfying. Photography had its limits, too. The image being static, I wanted to be able to manipulate it as I had done in painting.

Digital printmaking provided the freedom to synthesize the two. With the technology of the digital world I am able to combine the captured moments of photography with the imaginative design of painting. Hours of reworking a problematic image are reduced significantly. Time is spent exploring and pushing the limits of the work without the fear of ruining it. Through the digital process I am able to cross-reference and move between both worlds of painting and photography.

In combining original photographs and scanned objects, my work is a synthesis of realism, abstraction, surrealism with a bit of trompe l'oeil. The realism of photography has not been abandoned entirely, but intertwined in the image is a reconstruction that transforms the initial perception. The pieces are intended to be experienced up close thereby drawing the viewer deeper into the image.







I have often enjoyed the artwork shown there and admired the friendly hand it extends to the community as people go about their business.






THE PAINTINGS OF LARRY VAN DEUSEN

I use the collage method for the composition of my paintings. I look to many sources, new and old, to create a contemporary blend. The composition is then reworked into a final drawing which is used as a model for the painting. I think of these layered paintings as a metaphor for the modern world, where we understand that at some level everything is connected to everything else.

What I'm seeking to do is keep two contradictory forces in play, and pushing them to the point where they might fall apart. Those forces are material realization- conception, planning, structure, knowing what I want the painting to do- and freedom- improvisation, happenstance, emotional expectations. I try to put the painting at the point where those two forces conjoin.

I have a degree in Sculpture from the University of California, Hayward. I have shown extensively in the United States and Europe with nineteen solo shows and over a hundred and forty group shows, as well as many art festivals, open studio's, artist panels, and TV interviews and discussions. My work can be found in many private and public collections.
