STAFF RECOMMENDATION

That Council authorize letters of appreciation to Fern Tiger Associates and Members of the Golden Gate Fields/Waterfront Task Force, and a letter inviting continued conversation with the owner of the Golden Gate Fields property (The Stronach Group).

BACKGROUND

Last year, the Golden Gate Fields property was selected as one of six potential sites for the second campus of the Lawrence Berkeley National Laboratory. To assist the community in being informed and engaged about the proposal, the City of Albany hired Fern Tiger Associates (FTA) to conduct various educational and outreach initiatives. FTA was the firm that conducted the City sponsored Voices to Vision waterfront visioning process in 2008-10, which provided Albany with recommended guidelines for the future of the GGF property. The property owner – The Stronach Group – agreed to reimburse the City for the costs to hire FTA to inform and engage the community about the proposal for the Lab and associated development.

FTA began the process by collecting as much information as possible in a very brief amount of time, followed by conducting engagement sessions with the community. Upon receipt of an interim report from Fern Tiger in September, the City Council established a Task Force to serve as a platform for further education in engagement with the community.

The 22-member Task Force was comprised of three appointees of each Council Member (with the exception of Council Member Lieber, who recused himself due to a conflict of interest); one appointee of each member of the Albany Board of Education; and the chairs or designees of the Planning & Zoning Commission; Parks & Recreation Commission; Traffic & Safety Commission; Waterfront Committee; and Sustainability Committee.

The Task Force met six times where it had iterative conversations and presentations related to site plan, economic impact, infrastructure, environmental impacts, land entitlements, taxes, ownership, open space, and other topics. In addition, the Task Force met with the City Council in a workshop on December 4, 2011 where it presented what members saw as

the pros, cons, and opportunities of the realities of the developer's intentions to develop the site with LBNL as the anchor project with related development (hotel, retail, offices, commercial labs, etc.) as part of the proposal in order to satisfy infrastructure costs, city funding needs, and to create the developer's vision for a technology park.

On January 23, 2012, the Lab announced that it had selected the Richmond Field Station as its preferred site for a second campus. At its meeting of February 6, 2012, the City Council directed staff to return to the City Council with draft correspondence of appreciation to FTA and the Task Force for their work, and draft correspondence to the property owner.

DISCUSSION

Attached are draft letters, as follows:

FTA: To Fern Tiger Associates expressing gratitude for the significant and excellent work by Fern Tiger and her team to inform and engage the community about the complex proposal, under time and information constraints.

Task Force: A draft letter to be individually addressed to each Task Force member thanking them for their dedication to understanding, analyzing, and evaluating the proposal, meeting on a weekly basis, and advising the City Council

The Stronach Group: To the property owner acknowledging the opportunity the Lab proposal provided for communication between the property owner and Albany, and inviting that conversation to continue.
