**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY
MANAGER TO ACCEPT
OFFERS OF DEDICATION OF EASEMENT
FOR THE BUCHANAN BICYCLE/PEDESTRIAN PATH PROJECT
FROM THE ALBANY UNIFIED SCHOOL DISTRICT
THE UNIVERSITY OF CALIFORNIA AND
THE U.S. DEPARTMENT OF AGRICULTURE.**

WHEREAS, the City of Albany desires to complete a variety of improvements to Buchanan and Marin Avenues to implement a safe and accessible bicycle/pedestrian path connecting the Marin Avenue bicycle path to the San Francisco Bay Trail; and

WHEREAS, a portion of the work is on property owned by the Albany Unified School District, the University of California and the U.S. Department of Agriculture; and

WHEREAS, the City has received a \$1.7 million grant from the Federal Highway Administration (FHWA) for construction of the project, which must be approved no later than April 30, 2012; and

WHEREAS, establishment and maintenance of easements over the effected lands is a requirement of the State, the property owners, and the granting agency (FHWA); and

WHEREAS, the offers of donation of easement will be received within the next ten days and must be approved in a timely manner in order to enable adequate time for State review and Federal approval;

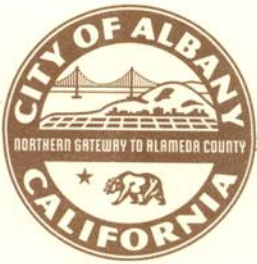
