5. GOOD OF THE CITY/PUBLIC FORUM/ANNOUNCEMENTS

Mayor Javandel opened the Good of the City/Public Forum/Announcements.

Mayor Javandel commented on the situation at the Gill Tract, noting that the City is in support of an agreement between the University and those at the Gill Tract. Mayor Javandel announced Bike to Work Day and Bike to School Day.

Council Member Lieber announced that he met with Keith Carson regarding the nurses strike, and also attended a campaign event for Barbara Lee this past Saturday.

Council Member Thomsen expressed appreciation to the Albany Lions Club for the contribution of \$500 to the Recreation Department in the name of Bill Johnson.

Vice Mayor Atkinson announced she attended the Arts & Green Festival this past Sunday.

Council Member Wile reported that she visited the farmers at the Gill Tract and expressed appreciation for the work being conducted.

A summary of the comments is as follows: announced Bike Rodeo on Saturday May 19th at Cornell School; expressed support for community farming at the Gill Tract, that the Gill Tract has prime farming soil and is a community resource; announced formation of the Albany Farm Alliance, encouraged Council to take action to support community farming, prohibit use of violence by UCPD, and reconsider development agreement; urged the City to honor the ongoing planning process and not allow people to create their own rules; concerned with safety at intersection with farm banners and signs; announced Bike Month and the work of Albany Strollers & Rollers/East Bay Bicycle Coalition.

Council Member Lieber stated that there is not a nexus between the Gill Tract and the development. The Gill Tract is included in UC's Mater Plan.

Council Member Wile stated that she will be working with the City Manager to formulate a Resolution that encourages a collaborative approach to establishing an urban farm at the Gill Tract.

7-1. Medical Marijuana Policy Update

City Planner Anne Hersch delivered the staff report. There are no new legal decisions to report, however there are four cases under review, two of which should be decided in the next 18-24 months. An update will be provided to Council when rulings become available.

A summary of Council comments is as follows: Council Member Lieber noted the interest of revisiting the Ordinance including review of boundary lines, and will return to Council to request that Council ask the Planning & Zoning Commission to further refine the Ordinance.

7-2. Loan Reauthorizations between the Successor Agency to the Albany Community Reinvestment Agency and the City of Albany

Staff recommendation: That the City Council authorize the City Manager of the City of Albany to re-enter into loan agreements for the following:

- 1) Loan Reauthorization Agreement #1 Pierce Street Parcel purchase (\$850,000)
- 2) Loan Reauthorization Agreement #2 City Advances (\$491,336)
- 3) Loan Reauthorization Agreement #3 Organization Expenses 1996 (\$194,867)

Mayor Javandel and Council Member Thomsen recused themselves due to proximity of their residences.

Projects Director Judy Lieberman delivered the staff report. A portion of property tax increases from redevelopment were utilized by the Albany Community Reinvestment Agency (ACRA) to fund or enable financing of debt for improvements to the redevelopment area (approximately 37 acres that run north-south along the City's western edge). The City loaned funds to the ACRA to implement improvements and projects. The State ordered dissolution of

Redevelopment Agencies as of February 1, 2012, requiring a successor agency and an oversight board to the successor agency. The City of Albany is the successor agency, and the oversight board to the successor agency is tasked with reviewing the successor agency's Recognized Obligation Payment Schedule (ROPS). The Oversight Board met on April 9, 2012 approving two of the three loan reauthorizations: Loan Reauthorization Agreement 1 – Pierce Street Property Purchase, and Loan Reauthorization Agreement 2 – Cash Advances. Loan Reauthorization Agreement 3 – Agency Formation, 1996 requires approval by the Oversight Board. Approval of the loan authorization agreements is necessary in order to repay the City for loans made to the ACRA, which will be utilized to fund future capital projects.

City Manager Pollard recommended that the Vice Mayor be authorized to execute the loan agreements for the City, and that Judy Lieberman, Projects Director be included as the Executive Director signature authority to ensure separation of the roles of the agencies.

There was no public comment on this item.

Council Member Lieber asked about legal concerns regarding the process.

City Attorney Craig Labadie indicated the current legislation does authorize the Oversight Board to re-enter into loan agreements. The City is currently operating under AB 26x1 as adopted last June.

8. NEW BUSINESS

8-1. Pierce Street Parcel Project.

Staff Recommendation: Authorize the City Manager to enter into a contract with BurksToma Architects (BTA) to begin the Phase 1 planning and design for the Pierce Street Parcel project for a maintenance center, park, and trail, in an amount

not to exceed \$165,506 and to enter into a contract with A3Geo, Inc., for Geotechnical Services in the amount of \$13,817.

Projects Director Judy Lieberman delivered the staff report. The Pierce Street parcel was purchased utilizing a combination of Albany Community Reinvestment Agency (ACRA) funds and a loan from the City of Albany to the ACRA. There are a number of current funding options, and funds are available to move forward with a public planning process and development of 35% plans. Following the purchase of the parcel in June of 2011, staff initiated a comprehensive process to select a lead architectural firm BurksToma to conduct a Master Plan for the site including a Maintenance Center, park for passive recreation, and a trail. The City worked with BurksToma to select a landscape architect firm. A Geotechnical consultant will also be utilized for development of the Master Plan. The proposal is to move forward on a phased approach with Phase I to be completed by Fall 2012 including geotechnical analysis, planning and public process, development of a site Master Plan, and a preliminary cost range for the three components. Following review of Phase I, Phase 2 would be initiated, completed in Winter 2013, and include development of specific design documents to 35%, cost estimates, and determination of project financing.

There was no public comment on this item.

A summary of Council comments is as follows: acknowledged the City is spending too much on the current lease for the Maintenance Center, general support for the project moving forward and working with other agencies, interest in utilizing modular buildings in the short-term, interest in ensuring participation of a working group, as well as involvement of the Council.

8-2. Bay Friendly Landscaping requirements for new construction and rehabilitation of public and private landscapes of 2,500 square feet of irrigated area or greater that require a permit, pursuant to a condition of funding by the Alameda County Waste Management Authority (Stopwaste.org)

Staff recommendation: The City Council of the city of Albany adopt Resolution No. 2012-31 approving Bay Friendly Basics.

City Planner Anne Hersch delivered the staff report. Stopwaste.Org has required that jurisdictions receiving Recycling Mitigation Funding must adopt the Bay Friendly Basics Requirements by June 30, 2012. The City receives \$23,724 in Mitigation funding for implementation of recycling programs. The Bay Friendly Basics require all new construction and rehabilitation of public and private landscapes of 2,500 square feet or more of irrigated area that require a permit, plan check or design review, shall adhere to the Bay Friendly Basics. The Bay Friendly Basics are intended to achieve resource conservation.

There was no public comment on this item.

8-3. City of Albany Street Banner Policy

That Council approve Resolution No. 2012-23, establishing the City of Albany Street Banner Policy.

Assistant City Manager/Community Services Director Penelope Leach delivered the staff report. The proposed street banner program would require that proposals for hanging street banners be submitted to the Community Development Department for approval. The Community Development Department will work with a 2-member subcommittee of the Arts Committee regarding banner submittals if there is uncertainty regarding compliance with the proposed policy. For banners intended to remain for 12 or more consecutive months, the Community Development Department will review the submittal for compliance, then forward to the Arts Committee for review and to make a recommendation to the City Council. The streets for banners include San Pablo, Solano and Buchanan.

The following people spoke: Peggy McQuaid, Barbara Chambers.

A summary of comments is as follows: the Arts Committee is interested in having banners that are unique to Albany; interest in a policy regarding hanging of banners in areas besides street poles, interest of a neighborhood watch sign.

A summary of Council comments is as follows: ensure appropriate size of banners so they are legible.

Council Member Lieber recommendation: 1) Sponsor a presentation at a City of Albany site by Lawrence "Rusty" Monroe, Center for Municipal Solutions (CMS) on the new federal wireless co-location law, and reimburse his out-of-pocket expenses only, estimated \$800 - \$1,000; and 2) Refer proposed building code modification regarding telecommunications towers to staff for recommendations to Council on incorporation into city regulations

Council Member Lieber discussed the item, and would like to have a presentation that can be recorded for the community. Also, the interest in updating the code to ensure public safety and protect against legal issues.

A summary of comments is as follows: support for updating the code, interest in finding a local representative to host a discussion, the code update should be referred to Planning & Zoning Commission; interest in bringing in additional cities to share cost, and looking to Association of Bay Area Governments (ABAG) for suitable people.

A summary of Council comments is as follows: interest in looking for local representatives that could speak on the item or using teleconferencing, interest in referring the code update to the Planning & Zoning Commission, interest in receiving legal point of view, interest in ensuring the code is updated including the issue of steel as compared to wood, support for proposed speaker given the level of experience and an alternative view.
