SUBJECT: Proposed Mini Golf at 1243/1245 Solano Ave.

> The applicant is preliminary feedback on a proposed mini golf course at 1243/1245 Solano Ave. The site is currently vacant and approximately 5,000 sq. ft. in area. The site is proposed to contain an 18 hole mini golf course with a 450 sq. ft. building containing a restroom, birthday party room, games, and a booth to hand out balls and putters. The applicant has not yet prepared plans or signed an agreement pending Commission feedback. No plans have been prepared or submitted to the City.

SITE: 1243/1245 Solano

APPLICANT: Wally & Andrea English

ZONING: Solano Commercial (SC)

STAFF RECOMMENDATION

Staff recommends that the Planning and Zoning Commission receive the memo for the proposed miniature golf business and determine the following:

- 1. Determine if there is Commission support for a miniature golf business on Solano.
- 2. The Planning & Zoning Commission may identify and request additional materials and exhibits to be submitted if the Commission decides to support the use.

Since this is a preliminary study session review, no action on the application is being requested as this time.

BACKGROUND/PROJECT DESCRIPTION

The subject property is a vacant 5,000 sq. ft. lot located at 1234/1245 Solano Ave. Previous uses at the site include the annual pumpkin patch and Christmas tree lot. Commercial buildings are located on the east and west sides of the property and have neighborhood commercial uses. The Albany Pre-School is located just north of the subject site.

SITE LOCATION




Figure 1. Site Location: 1234/1245 Solano Ave.

ANALYSIS

The applicant would like to construct an eighteen (18) hole miniature golf course with a 450 sq. ft. building which will include a bathroom, birthday party room, games, and booth to distribute putters and golf balls. Outdoor lighting is also proposed for evening play. The business would operate Sunday-Thursday 11am-9pm and Friday, Saturday, and holidays from 9am-10pm.

The applicant has discussed the idea of miniature golf with the landlord of 1243/1245 Solano. The owner has indicated that he would be supportive of a miniature golf use at the site. To date, he has not entered into a lease agreement or hired a project architect. The applicant has indicated that a professional miniature golf course design firm would design the project. Due to the unique nature of this use and request, staff recommended that this be brought to the Planning & Zoning Commission as a study session item first.

Parking

The subject site does not have any off-street parking. Also, the Albany Municipal Code does not have any parking standards related to outdoor recreation or miniature golf uses. Staff has briefly searched other municipal codes to determine appropriate parking standards for

miniature golf. Locally, the City of Vallejo requires 3 spaces/hole. If the Commission decided that this is a use which can be supported, a more extensive parking survey would be prepared.

Next Steps

If the Commission supports the project idea, the applicant would need to file a formal application request for a Conditional Use Permit, Design Review, and Parking Exception for the miniature golf course.
