A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO APPROVE A REIMBURSEMENT AGREEMENT WITH EAST BAY MUNICIPAL UTILITY DISTRICT FOR THE CONSTRUCTION OF THE RECYCLED WATER PIPELINE IN BUCANAN MARIN BIKEWAY PROJECT, PIERCE ST. TO SAN PABLO AVE

WHEREAS, the City of Albany and the East Bay Municipal Utility District (EBMUD) have been working cooperatively, since 2001 to bring recycled water to the City of Albany; and WHEREAS, on September 20, 2012 bids for the Buchanan/ Marin Bikeway Pierce St. to

San Pablo Ave, Contract No. C12-2, received; and

WHEREAS, at the request of EBMUD the plans and specifications for the Buchanan/Marin Bikeway project included a bid item for the construction of a recycled water pipeline; and

WHERAS, attached hereto and incorporated herein by reference is an agreement for reimbursement for the costs to construct the recycled water pipeline on Buchanan and Marin from Pierce Street to San Pablo Avenue; and

WHEREAS, the attached agreement provides that the City be reimbursed for cost to construct the recycled water pipeline from Pierce Street to San Pablo Avenue in the amount of \$79,200; and

WHEREAS, the attached agreement provides that additional costs incurred by the Contractor in connection with the construction of the recycled water pipeline, if any, will be paid for by EBMUD; and

WHEREAS, the City Engineer and the Community Development Director recommend that the Council approve the attached agreement.

NOW, THEREFORE, BE IT RESOLVED, that the City Manger is authorized to approved the attached reimbursement agreement with EBMUD for the Buchanan/Marin Recycled Water Pipeline, Pierce Street to San Pablo Avenue; and

BE IT FURTHER RESOLVED, the City Clerk is directed to forward an executed original of the Agreement to EBMUD.
