**A RESOLUTION OF THE ALBANY CITY COUNCIL AMENDING  
RESOLUTION NO. 06-38 TO REVISE LOCATIONS FOR POSTING OF  
OFFICAL NOTICES WITHIN THE CITY OF ALBANY**

**WHEREAS**, the Charter of the City of Albany, Section 2.07, requires that official notices and ordinances be posted at three (3) public places within the City, and that the City Council, by Resolution, shall designate three (3) public places for posting of official notices within the City; and

**WHEREAS**, Resolution No. 06-38 confirmed the locations for the posting of official notices within the City of Albany to include the following locations:

- Albany City Hall, 1000 San Pablo Avenue
- Albany Fire Department, 1001 Marin Avenue
- Albany Library/Community Center building, 1247-1249 Marin Avenue; and

**WHEREAS**, the current posting locations at City Hall and the Fire Department are in close physical proximity to one another; and

**WHEREAS**, changing from the existing posting location at the Fire Department to the Albany Senior Center will provide for improved public accessibility to official notices; and

**NOW THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby amends the established locations for posting of official notices to include the following approved locations and declares that said locations are determined to

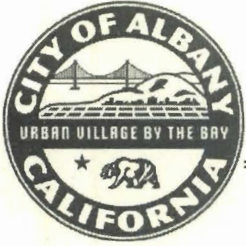
1 currently be the most public places within the City of Albany for the posting of
