A summary of comments is as follows: expressed congratulations to Council Members and encouraged continuation of transparency and open dialogue; presented award to the Council regarding City of Albany compliance with recycling regulations for commercial businesses and multifamily; encouraged applications for the Waterfront Committee; requested installation of hearing loops for members that may be hard of hearing; encouraged Council to revisit health care benefits provided to Council and scale back these benefits; expressed concern with battery recycling options at City facilities.

# 9-1. 2012-13 City Council Goals and Objectives Progress Report

Staff recommendation: Receive progress report and provide any additional direction

City Manager Beth Pollard delivered the staff report, including a status update on the three key objectives highlighted during adoption of the goals and objectives: General Plan: Council authorized issuance of a Request for Qualifications and four responses were received. Interviews are now being conducted with a recommendation to the City Council for selection of a consultant scheduled for February.

Homelessness: the Homeless Task Force has met monthly since July, and now also includes a homeless member as selected by the Task Force and authorized by the City Council. An interim report will be provided to the Council on January 22, 2013.

Information Technology: an assessment of the City's computer network is complete, finding that the network requires redesign. Additional information will be presented to the Council as part of the January 22, 2013 meeting.

Additional priorities were noted including improving the City's and community's response during a disaster, proving a variety of avenues for face-to-face and electronic communications in the community and between city officials and the public, implementation of climate action, active transportation and sustainability policies/plans and creation of a "Complete Streets" strategy for improvements to San Pablo Avenue, and conducting strategic planning for the next cycle of goals, objectives and budgeting with the seating of the new City Council in January. The strategic planning includes updating the City's General Plan, identification of City Council vision, strategic issues and direction, goals and preliminary objectives, and City organizational values. Issuance of a Request for Proposals to obtain a consultant to assist with the strategic planning is recommended.

The following people spoke: Francesco Papalia; David Sanger

A summary of comments is as follows: concern with limited staffing in Planning Department and interest in moving projects forward more efficiently; interest in enhancing communications, community involvement, and facilitation of lively discussions.

A summary of Council comments is as follows: interest in facilitating additional communication opportunities for the public including social media and face to face communications; interest in the pursuit of a Community Choice Aggregation with assistance from the Sustainability Committee; interest in receiving information regarding cell phone towers and an update from the RF Consultant as part of a future agenda.

# 9-2. Bi-annual Review of City Advisory Bodies

Staff recommendation: Approve Resolution No. 2012-80 to: 1) Establish policies and procedures for creating Task Forces, and guidelines for recommendations from advisory bodies to the City Council; 2) Continue the practice of reviewing the advisory bodies bi-annually; 3) Modify the regular meeting schedules of the Charter Review and Waterfront Committees to every other month, unless more frequent meetings are needed due to the press of business; 4) Continue the two appointees from the Social & Economic Justice Commission on the Homeless

Task Force, and otherwise sunset the Commission; and 5) Modify the composition of the following bodies:

- a. Arts Committee: One appointee per Council Member, one appointee atlarge by the City Council, and one appointee at-large by the Board of Education
- b. Library Advisory Board: One appointee per Council Member
- c. Sustainability Committee: Authorize the Board of Education to appoint either a student or an adult.

City Manager Pollard delivered the staff report. Per Resolution No. 2010-63, a follow up review of the status of the City's Advisory Bodies was conducted. Guiding principles included seeking to ensure engaged, thoughtful participation by members that results in effective outcomes. In addition to the changes identified in the staff recommendation, policies and procedures for City Council appointment of Task Forces are proposed as well as the recommendation that Advisory Body Recommendations to City Council be in the form of "pros and cons", and that the Advisory Bodies continue to be reviewed on a bi-annual basis.

The following people spoke: Ruth Cashmere, Social & Economic Justice Commission Chair; Judy Kerr, Social & Economic Justice Commission Member; Margie Marks, Social & Economic Justice Commission Member; Signe Matison; Francesco Papalia, Waterfront Committee Chair; Caryl O'Keefe; Brian Parsley; Peggy McQuaid; Thelma Rubin; Paul O'Curry.

A summary of comments is as follows: Interest in continuation of Social & Economic Justice Commission; interest in flexibility of meeting format; support for a Task Force approach to issues; general support for recommendations; the Advisory Body training should be mandatory or those not attending should not be allowed to serve on an Advisory Body; concern with unstaffed meetings due to potential legal issues; interest in Social & Economic Justice issues being considered as part of the decision of all groups, and including a section in staff reports.

A summary of Council comments is as follows: general support for the recommended changes, interest in continuing the Social and Economic Justice Commission for an additional six months to a year and to have staff support for the group.

#### **MOTION:**

Moved by Council Member Atkinson, seconded by Vice Mayor Wile to Approve Resolution No. 2012-80, with the exception that the Social & Economic Justice Commission shall remain in effect for one year with a status report back to the City Council.

Council Member Barnes suggested a friendly amendment to allow the Social & Economic Justice Commission to continue for six months. The friendly amendment did not receive a second.

Sustainability and Transportation Coordinator Claire Griffing delivered the staff report. The Alameda County Waste Management Authority has created an Energy Council Joint Powers Authority intended to comprise all jurisdictions within Alameda County to collaboratively seek funding and implement regional energy efficiency projects. The Sustainability Committee supports the City's participation in the Energy Council JPA.

The following people spoke: Tom Cooper, Sustainability Committee Chair. A summary of comments is as follows: encouraged the Council to approve the Resolutions as the program allows the City to leverage an advantage and make a large impact towards achieving energy efficiency.

A summary of Council comments is as follows: interest in the collaborative approach and ability to obtain grant funding for projects; interest in regional efforts regarding energy efficiency.
