A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY OF ALBANY FIRE DEPARTMENT TO ACCEPT A GRANT AWARD OF \$135,938.00 AND A GRANT AWARD OF \$136,802.00 FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY’S (FEMA) ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM

WHEREAS, the Assistance to Firefighters Grant program was established by FEMA after the September 11th, 2001 terrorist attacks, and is intended to assist in meeting the firefighting and emergency response needs of fire departments; and

WHEREAS, in July of 2012 the Albany Fire Department applied for grants through the Federal Emergency Management Agency Assistance to Firefighters Grant Program for the purchase of an ambulance as well as Self Contained Breathing Apparatus (SCBA’s); and

WHEREAS, the Fire Department has received notification that a grant for the purchase of an ambulance for the City of Albany has been awarded in the amount of \$135,938.00; and


WHEREAS, accepting this grant award will allow the Fire Department to meet a critical need with a new Type III ambulance; and

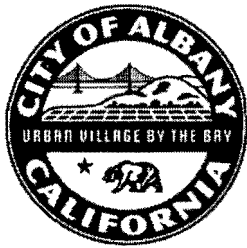
