**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALBANY  
AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT  
WITH THE SAN FRANCISCO ESTUARY PROJECT (SFEP) AND  
ASSOCIATION OF BAY AREA GOVERNMENTS (ABAG) REGARDING  
THE DESIGN, CONSTRUCTION, MAINTENANCE AND MONITORING OF THE  
SAN PABLO AVENUE STORMWATER SPINE PROJECT**

**WHEREAS**, in 2010 the San Francisco Estuary Project (SFEP), in cooperation with the Association of Bay Area Governments (ABAG), invited the City of Albany to participate in the San Pablo Avenue Stormwater Spine Project; and

**WHEREAS**, on December 6, 2010, the City Council of the City of Albany recommended support for the project, and proposed several stormwater planter locations within Albany along San Pablo Avenue; and

**WHEREAS**, SFEP applied for and was awarded a Bay Area Proposition 84 Integrated Regional Water Management (IRWM) Grant funding from the California Department of Water Resources to construct the Project, and maintain and monitor it for the first two years following construction completion; and

**WHEREAS**, the project will benefit the City of Albany by constructing stormwater planters that will improve stormwater quality, air quality and increase biological habitat; and

**WHEREAS**, design, construction and the first two years of maintenance and monitoring of the stormwater planters will be paid for by IRWM grant and Caltrans; and

**WHEREAS**, SFEP/ABAG is requesting that the City of Albany enter into a Project Agreement that outlines SFEP/ABAG Obligations, Entity Obligations, and includes a Work Plan and Project Monitoring Plan Requirements.

**NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby authorizes the City Manager to enter into a Project Agreement with SFEP/ABAG approving the City's participation in the San Pablo Avenue Stormwater Spine Project.
