**BE IT FURTHER RESOLVED** that the City Council hereby levies the assessments as set forth in the report of the Engineer for fiscal year 2013/14; and

**BE IT FURTHER RESOLVED** that the City Clerk is authorized and directed to immediately file the Engineer's Report for Assessment District No. 1988-1 for the 2013/14 fiscal year together with a certified copy of this resolution with the Alameda County Auditor.
