SUBMITTING AN APPLICATOIN TO THE ALAMEDA CTC FOR THE
SUSTAINABLE COMMUNITIES TECHNICAL ASSISTANCE PROGRAM
(SC-TAP) FOR PUBLIC PROCESS AND DEVELOPMENT OF DESIGN
OPTIONS FOR BICYCLE FACILITIES ALONG KAINS AND ADAMS
STREETS**

WHEREAS, The City of Albany is an eligible applicant under the SC-TAP guidelines, and

WHEREAS, Kains Street and Adams Street are located in the immediate vicinity of San Pablo Avenue, a potential Priority Development Area, and

WHEREAS, the City of Albany is updating its General Plan and with this update, its Housing Element will be evaluated and updated, and

WHEREAS, the City of Albany adopted its Active Transportation Plan in 2012, and

WHEREAS, the further evaluation of implementing bicycle facilities along Kains and Adams Streets as alternatives to bicycle travel along San Pablo Avenue is recommended in the Albany Active Transportation Plan (ATP), and



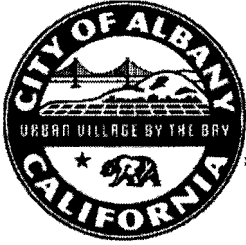
