**RESOLUTION NO. 2013-44**

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO SIGN PROFESSIONAL SERVICE AGREEMENTS FOR NUTE ENGINEERING AND HYDROSCIENCE TO DESIGN AND PREPARE CONSTRUCTION BID DOCUMENTS FOR KEY ROUTE BOULEVARD SEWER PIPE REHABILITATION AND FOR A 24-INCH TRUNK LINE REHABILITATION.**

**WHEREAS**, the City of Albany uses a blend of in-house staff and consultants to deliver engineering services; and

**WHEREAS**, on April 15, 2013 Albany City Council authorized the City Manager to sign Professional Service Agreements with Nute Engineering and Hydroscience, as on-call sewer engineering consultants; and

**WHEREAS**, the City of Albany is required by federal court order to rehabilitate sanitary sewer pipe each year; and


**WHEREAS**, the City has identified deteriorated sanitary sewer pipe in need of rehabilitation; and

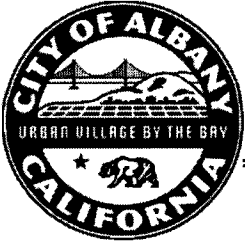
**WHEREAS**, Request for Proposals were circulated to the City on-call sewer engineering consultants for services to design and prepare construction bid documents for two separate sanitary sewer rehabilitation projects; and

**WHEREAS**, City staff selected the most suitable on-call consultant to conduct the sanitary sewer design work; and

**WHEREAS**, the design fees for the sanitary sewer rehabilitation projects exceed the previously authorized \$30,000 per engagement limit for on-call sewer engineering consultants.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Albany that the City Manager is authorized to sign Professional Service Agreements for Nute Engineering and HydroScience for services totaling \$67,982 and \$39,408, respectively.
