**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
SUBMITTAL OF AN APPLICATION TO THE STATE WATER
RESOURCES CONTROL BOARD (SWRCB) FOR THE PROPOSITION 84
STORMWATER GRANT PROGRAM (SWGP) FOR THE BRIGHTON
STREET PILOT GREEN STREET PROJECT**

WHEREAS, The State Water Resources Control Board (SWRCB) is in the process of accepting concept proposal applications for the Proposition 84 Stormwater Grant Program (SWGP); and

WHEREAS, the SWRCB is looking for projects which reduce storm water pollution, implement Low Impact Development (LID), provide multiple benefits, are technically feasible, are ready to proceed and are coordinated with an Integrated Regional Water Management (IRWM) Plan; and

WHEREAS, The goal of these proposed street improvements will be to meet the objectives of the Stormwater Program with the added benefit of providing pedestrian safety in the vicinity of Albany Middle School; and

WHEREAS, One of the goals of the City Council Strategic Plan is to “Inspire Community Climate Action”. Low Impact Development (LID) practices help implement Climate Action Plan Measure GI-1.1; and

WHEREAS, the Brighton Street Pilot Green Street Project proposes to add biofiltration planters at the intersections with bulb outs to provide stormwater treatment as well as provide additional safety to pedestrians; and

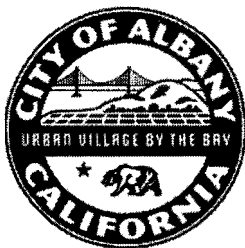
