3 **A RESOLUTION OF THE ALBANY CITY COUNCIL AMENDING THE**  
4 **ADOPTED FISCAL YEAR 2013-2014 BUDGET AND APPROPRIATING**  
5 **FUNDS FOR THE IMPLEMENTATION OF THE ALBANY**  
6 **WATERFRONT PARK TRANSITION PLAN "ACT"**

7       **WHEREAS**, the Albany City Council Strategic Plan, adopted in 2013 includes a  
8 goal to Maximize Park and Open Space including development of a plan to transition the  
9 Bulb into the McLaughlin Eastshore State Park and to improve accessibility for general  
10 public use of all of the Albany Bulb as a waterfront park; and

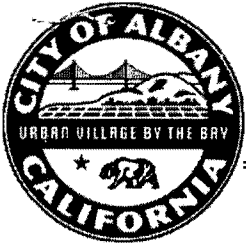

12       **WHEREAS**, recent action taken by the City Council on May 6, 2013, June 17,  
13 2013 and September 3, 2013 authorized retaining the services of Berkeley Food and  
14 Housing Project for ongoing outreach & engagement to homeless within the City;  
15 directed the Police Department to enforce the no camping ordinance as of October 2013;  
16 and approved the Mayor, Vice Mayor and City Manager meet with East Bay Regional  
17 Park District and State Parks to begin a process transition the Albany Bulb to the  
18 McLaughlin Eastshore State Park; and

20       **WHEREAS**, the City of Albany continues to move forward with efforts to assist  
21 homeless on the Albany Bulb, and also provide an accessible public park; and

22  
23       **WHEREAS**, the "*Albany Waterfront Park Transition Plan-ACT*" addresses  
24 three major goals for transitioning the Bulb "*ACT*", and identifies how each goal will be  
25 achieved:

- 26       1. Assistance to Homeless including housing-centered outreach, transitional  
27       services, support, and shelter.  
28       2. Clean up of the Bulb.  
29       3. Transfer of the Bulb to McLaughlin Eastshore State Park; and
