9	WHEREAS, On December 6, 2004, the City Council of the City of Albany
10	adopted Ordinance #04-09 establishing Chapter XX "Planning and Zoning" of the
11	Albany Municipal Code; and
12	
13	WHEREAS, Chapter XX established development standards and review
14	procedures for new single family home construction; and
15	
16	WHEREAS, the City Council adopted Residential Design Guidelines for
17	residential additions and new homes in the City of Albany which provide specific
18	design elements that encourage thoughtful development, interaction between
19	neighbors and a sense of community in an urban environment; and
20	
21	WHEREAS, Linvill Pond Architects submitted an application for Design
22	Review and a Conditional Use Permit for a new single family home at 726 Cerrito St.
23	on August 1, 2013; and
24	
25	WHEREAS, the property at 726 Cerrito St. is a vacant lot located in the "R-
26	1" (Residential Single Family) zoning district and has an overlay designation of
27	"Hillside Overlay District"; and
28	
29	WHEREAS, the Planning & Zoning Commission reviewed and approved
30	Design Review and the Conditional Use Permit for 726 Cerrito St. at its September
31	11, 2013 hearing; and

WHEREAS, Jim & Kim Cleveland (appellants) filed an appeal of the Planning & Zoning Commission decision on September 25, 2013; and

WHEREAS, the appeal cites discrepancies in the site survey and concerns related to project height; and

WHEREAS, City staff scheduled the appeal hearing for City Council on October 21, 2013 pursuant to Section 20.100.080 (E) (1) which requires that the appeal be scheduled within thirty (30) days of the initial filing; and

WHEREAS, a public hearing notice was mailed to property owners within 300 ft. of the subject site and was posted in three public places on Friday October 11, 2013 for the City Council appeal pursuant to Government Code Section 65090; and

WHEREAS, on October 21, 2013 the City Council continued the matter to a date uncertain so that discrepancies in the site surveys could be resolved; and

WHEREAS, the City scheduled the hearing for November 18, 2013 pursuant to Section 20.100.080 (E) (1) which requires that hearing be set within thirty (30) days of the appeal filing and that the hearing be held within sixty (60) days of the original Planning & Zoning Commission hearing; and

WHEREAS, a public hearing notice was mailed to property owners within 300 ft. of the subject site and was posted in three public places on Friday November 8, 2013 for the City Council appeal pursuant to Government Code Section 65090; and

WHEREAS, the City Council held a public hearing on November 18, 2013 considered all public comments received, the presentation by City staff, the staff report, and all other pertinent documents regarding the proposed request;

ì	WHEREAS, Planning and Zoning Code Section 20.100.080.F establishes the

19	1. FINDINGS FOR EXEMPTION FROM CEQA		
20			
21	Finding: The project is Categorically Exempt from the California Environmental		
22	Quality Act Guidelines pursuant to Section 15303 "New Construction or		
23	Conversion of Small Structures".		
24			
25	Evidence: The proposed application would result in construction of a modest		
26	sized single family residence in an R-1 Zoning District.

28	2. FINDINGS FOR APPROVAL OF DESIGN REVIEW		
29

Findings for Design Review approval (Per section 20.100.050.E of the AMC)

1. Finding Required for Approval: The project conforms to the General Plan, any applicable specific plan, applicable design guidelines adopted by the City of Albany, and all applicable provisions of this Chapter.

> Evidence: The General Plan designates this area for residential development. Additionally, the project meets City zoning standards for location, intensity and type of development.

2. Finding Required for Approval: Approval of project design is consistent with the purpose and intent of this section, which states "designs of projects...will result in improvements that are visually and functionally appropriate to their site conditions and harmonious with their surroundings, including natural landforms and vegetation. Additional purposes of design review include (but are not limited to): that retention and maintenance of existing buildings and landscape features are considered; and that site access and vehicular parking are sufficient."

Evidence: The proposal is in scale and harmony with existing development in the vicinity of the site. The architectural style, design and building materials are consistent with the City's Residential Design Guidelines. The project will not require significant grading or excavation with Conditional Use Permit for front yard setback. Additionally, the proposed new home is attractive in appearance, and is in scale with the surrounding properties.

3. Finding Required for Approval: Approval of the project is in the interest of public health, safety and general welfare.

Evidence: The proposed project will result in a new home similar in size and character to others an existing residential neighborhood.

4. <u>Finding Required for Approval:</u> The project is in substantial compliance with applicable general and specific Standards for Review stated in Subsection 20.100.050.D.

Evidence: The project as designed is in substantial compliance with the standards as stated, including harmonious materials, and well proportioned massing.

3. FINDINGS FOR APPROVAL OF CONDITIONAL USE PERMIT

1. <u>Finding Required for Approval:</u> The size, location and intensity of the project are desirable and compatible with the neighborhood and community.

Evidence: The General Plan designates this area for Low Density Development. Additionally, the project meets City zoning standards for location, intensity and type of development.

- 2. <u>Finding Required for Approval:</u> The project will not be detrimental to the health, safety, convenience or general welfare of people residing or working in the vicinity, or injurious to property, improvements or potential development in the vicinity, with respect to aspects including but not limited to the following:
 - a. The nature of the proposed site, including its size and shape, and the proposed size, shape and arrangement of structures
 - b. The accessibility and traffic patterns for persons and vehicles, the type and volume of such traffic, and the adequacy of proposed off-street parking and loading.

- c. The safeguards afforded to prevent noxious or offensive emissions such as noise, glare, dust and odor.
- d. Treatment given, as appropriate, to such aspects as landscaping, screening, open spaces, parking and loading areas, service areas, lighting and signs.

Evidence:

- a. The site is of sufficient size and shape to successfully construct a new single-family residence. The applicant has taken the site grade into consideration with the project design and designed the structure to minimize grading to the extent possible.
- b. The project will not have any increased traffic impacts.
- c. The project will not develop significant new noxious noise, glare, dust or odor emissions beyond those associated with initial construction activities.
- d. The applicant has taken care to preserve neighboring views, minimize tree removal, and accommodate new landscaping.
- 3. <u>Finding Required for Approval:</u> That such use or feature as proposed will comply with the applicable provisions of this Chapter and will be consistent with the policies and standards of the General Plan.

Evidence: The proposed project is otherwise consistent with the City's General Plan zoning standards and requirements relating new single-family home construction.

Project Approval. This Design Review approval is for 726 Cerrito Street, as substantially shown and described on the project plans, except as may be modified by conditions herein. Plans prepared by Christopher Linvill and Mike Pond Architects, date received August 1, 2013, as presented to the Planning and Zoning Commission on September 11, 2013 and presented to the City Council on November 18, 2013. For any condition herein that requires preparation of a Final Plan where the project developer has submitted a conceptual plan, the project developer shall submit final plan(s) in substantial conformance with the conceptual plan, but incorporate the modifications required by the conditions herein for approval by the City.

Project Approval Expiration. This Design Review approval expire on December 2, 2014 (one year from the date on which this approval becomes effective) or at an alternate time specified as a condition of approval, unless a building permit has been issued and construction diligently pursued. The approval may be renewed by the Community Development Director for a period up to an additional two (2) years, provided that, at least ten (10) days before expiration of one (1) year from the date when the approval becomes effective, an application for renewal of the approval is filed with the Community Development Department. The Community Development Director may grant a renewal of an approval where there is no change in the original application, or there is no request to change any condition of approval.

Fees. The applicant shall pay any and all City and other related fees applicable to the property, as may be modified by conditions herein. Fees shall be based on the current fee structure in effect at the time the relevant permits are secured, and shall be paid before issuance of said permit or before any City Council final action approval. The project developer shall also reimburse the City for direct costs of planning; building and engineering plan check and inspection, as mutually agreed between the City and developer.

INFR-6 Completion of Off-Site Improvements. Off-site improvements, as required by the City Engineer, shall be complete before issuance of a Certificate of Occupancy unless alternatives are approved in writing by the Albany City Engineer.

PUBLIC IMPROVEMENTS CONDITIONS

This shall include sidewalk repair, slurry seal, street reconstruction or others, as may be required by the City Engineer.

Right-of-Way Construction Standards. All improvements within the public right-of-way, including curb, gutter, sidewalks, driveways, paving and utilities, shall be reconstructed in accordance with approved standards and/or plans and shall comply with the standard plans and specification of the Community Development Department and Chapter 14 of the City Code.

FIRE DEPARTMENT CONDITIONS

Construction of 1,500 Square Feet or Greater. 1500 sq. ft. or more or any addition, remodel, rehabilitation, etc. is 50% of the existing sq. ft.:

- a) This dwelling will be required install an Automatic Fire Extinguishing System throughout the entire dwelling. Ordinance No. 94-010, Albany Municipal Code, Chapter 11, Section 11-2.3a(3)(a).
- b) Plans, information sheets on all sprinkler components and hydraulic calculations are required.

1 c) A 110-volt interconnected smoke alarm system with a 10-year 2 lithium battery back-up is acceptable with a fire suppression 3 system. 4 5 FIRE-2 Fire Rated Construction. Any portion of a building five (5) feet or 6 less from the property line shall comply with fire-rating requirements 7 of the CBC. 8 9 FIRE-3 Gallons-per-Minute Requirement. The water system for fire 10 protection shall comply with City of Albany Fire Department 11 standards. Fire flow test data and water system plans must be provided at time of building plan check. The plans must include all equipment, 12 components and layout of the system. Private fire protection water 13 14 systems shall be supplied through an approved backflow device per 15 City Engineering Division standards. 16 Distance From Fire Hydrant. Before building permit issuance the 17 FIRE-5 18 distance from existing fire hydrants to the building shall be verified 19 and if necessary, a new hydrant shall be shown on the plans and installed prior to combustible construction. 20 21 22 Structural Control Measures 23 24 STRUC-1 Illegal Dumping to Storm Drain Inlets and Waterways. On-site 25 storm drain inlets shall be clearly marked with the words "No 26 Dumping! Flows to Bay," or equivalent, using methods approved by the City of Albany. 27 28 29 STRUC-2 Pesticide/Fertilizer Application Landscaping shall be designed to minimize irrigation and runoff, promote surface infiltration where 30 31 appropriate, and minimize the use of fertilizers and pesticides that can 32 contribute to stormwater pollution. If a landscaping plan is required as part of a development project application, the plan shall meet the 33 following conditions related to reduction of pesticide use on the 34 35 project site: Where feasible, landscaping shall be designed and operated to 36 a) treat stormwater runoff by incorporating elements that collect, 37 detain, and infiltrate runoff. In areas that provide detention of 38 39 water, plants that are tolerant of saturated soil conditions and prolonged exposure to water shall be specified. 40 Plant materials selected shall be appropriate to site specific 41 **b**) 42 characteristics such as soil type, topography, climate, amount and 43 timing of sunlight, prevailing winds, rainfall, air movement, patterns of land use, ecological consistency and plant interactions 44

to ensure successful establishment.

21	BMP-CNST5	Filter Materials at Storm Drain Inlet. Install filter materials (such
22		as sandbags, filter fabric, etc.) at the storm drain inlet nearest the

35 36		the site for the storage of bags of cement, paints, flammables, oils, fertilizers, pesticides, or any other materials used on the project site

40	BMP-CNST7	Cleaning of Equipment. Never clean machinery, tools, brushes, etc.
41		or rinse containers into a street, gutter, storm drain or stream. See the
42		Building Maintenance/ Remodeling flyer for more information.
43 44	BMP-CNST8	Minimize Removal of Natural Vegetation. Minimize removal of
45	DIVII -CROIO	natural vegetation or ground cover from the site in order to minimize
46		the potential for erosion and sedimentation problems. Replant the area

as soon as possible. All cut and fill slopes shall be stabilized as soon as possible after grading is completed. No site grading shall occur between October 1 and April 15 unless approved erosion and sedimentation control measures are in place.
