1. CALL TO ORDER

The meeting was called to order by Chair O'Keefe at 7:32 p.m.

3. APPROVAL OF MINUTES

3-1. February 25, 2013

Jordan noted two edits to the minutes.

Moved by Jordan, seconded by Baty minutes approved unanimously as amended.

- **6-1.** Finalize review of election methods utilizing criteria for judging methods as selected by the Committee, review and approve the following documents to forward to the City Council:
 - a. Table summarizing election methods and review criteria (Baty)

 The Committee reviewed the summary table and recommended edits. Baty will revise and provide final version at the next meeting.
 - b. Review draft report regarding review of election methods (Jordan)

 The Committee reviewed the draft report and recommended edits. Jordan will revise and provide a final version at the next meeting.
 - c. Cover memo (O'Keefe)
 - The Committee reviewed the draft cover memo and recommended edits. O'Keefe will provide a revised version at the next meeting. The Committee asked Almaguer to inquire with the City Attorney regarding the allowed mechanism to change the election method for City Council and/or the Board of Education Members.
 - d. Continued review of identified responses to questions raised by City Council Member Thomsen (O'Keefe)
 - The Committee reviewed the two versions of responses to questions raised by City Council Member Thomsen. Jordan noted that he provided an alternative version to clarify particular facts and add detail. Baty agreed to work on merging the two versions of the response to questions together. O'Keefe requested that the response to questions remain as neutral as possible.
- **6-2.** City Council referred item: appointment of standby officers to serve in the event of an emergency should a Council Member become unable to perform their duties.

Receive feedback from City Attorney regarding non-conflict with the City's Charter

Almaguer reported that the City Attorney reviewed the matter including initial questions raised by the Committee. The City Attorney found the appointment of standby officers by the City Council to not be in conflict with the City's Charter. As such, the matter will return to City Council for action in the future.

Discuss process for reviewing term limits and identify next steps to obtain direction from the Board of Education

The Committee requested Almaguer coordinate with the School District to provide the Charter reference regarding Board of Education term limits, and that a change in term limits would require an amendment to the Charter.

Review work plan, identify projects that have been completed, and any new projects for current year. This item was not discussed and will be included as part of the next agenda.
