BACKGROUND INFORMATION

The Board has received presentations on various portable classroom options at the San Gabriel site. The Board has heard Albany Middle School's need for additional space and Albany High School's need additional space for future Career Technology Education programs. The Board has heard the recommendation of the Facilities Master Plan Steering Committee to relocate the District Offices to the San Gabriel site.

Although classroom space can be added to the high school and the middle school, the sites are already considered "critically overcrowded" by State of California standards. Adding more buildings to either site will only compound the existing space problems.

The District has \$3,414,943.00 in Measure E funds. This is not enough money to meet AMS and AHS current/future needs for "stick built" construction.

Of primary importance is future construction flexibility. Although there may not be enough money to build a second story now at the San Gabriel site, it is important to factor that possibility into the final decision. The Facilities Master Plan Steering Committee recommends relocating the District Offices to the San Gabriel site. That will require the ability to add a second story to the portable buildings.

Staff recommends purchasing Growth Point portables for the San Gabriel site (see attached). They are the only portable that allows for adding a second story at a future date. They meet the City and School District desires for sustainability and are Leed platinum attainable. They have the longest life span and can be easily moved to another site should the district desire to repurpose the site in the future.

RECOMMENDATION:

Approve Purchase of Growth Point Portable Classrooms & Multi-Purpose Room For Use at the San Gabriel Site – Contingent Upon the Passage of a Ballot Measure Changing the Permitted Use of Measure E Funds.
