**RESOLUTION NO. 2014-6**

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXTEND THE CONTRACT WITH BERKELEY FOOD AND HOUSING PROJECT (BFHP) TO CONDUCT THE CITY'S HOMELESS OUTREACH AND ENGAGEMENT PROGRAM FOR A PERIOD OF 1 YEAR AT A COST NOT TO EXCEED \$76,000**

**WHEREAS**, on May 6, 2013 the City Council directed staff to issue a Request for Proposals (RFP) for an organization to conduct outreach and engagement services for a period of three months to people in Albany who are homeless; and

**WHEREAS**, on June 17, 2013 the City Council authorized the City Manager to enter into a Professional Services Agreement for a Homeless Outreach and Engagement Program with Berkeley Food and Housing Project (BFHP) for \$30,000; and

**WHEREAS**, on September 3, 2013, the City Council extended BFHP's contract until December 31, 2013 and allocated an additional \$30,000; and

**WHEREAS**, the contract was subsequently extended once more to January 21, 2014; and

**WHEREAS**, BFHP serves a highly vulnerable population of long-term disabled homeless, unstably housed and indigent residents through a multi-site, multi-service continuum of care; and

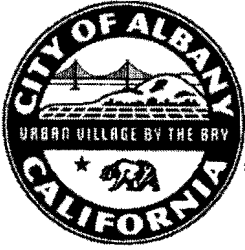
**WHEREAS**, Berkeley Food and Housing Project (BFHP) began providing services and activities for Albany Project HOPE, the City's Homeless Outreach and Engagement Program July 1, 2013; and

1           **WHEREAS**, the extension will allow BFHP to build upon the outreach and  
2 engagement done to date, including offering housing assistance and support to willing  
3 homeless individuals, and housing retention support to people who have been housed;

6           **WHEREAS**, services will be provided for the entire year, and outreach will be  
7 provided throughout the City.

9           **NOW THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby  
10 Authorizes the City Manager to extend the contract with Berkeley Food and Housing  
11 Project (BFHP) to conduct the City's Homeless Outreach and Engagement program for a  
12 period of 1 year at a cost not to exceed \$76,000.
