**RESOLUTION NO. 2014-5**

**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH GILLIS + PANICHIPAN ARCHITECTS FOR PUBLIC WORKS SERVICE CENTER DESIGN SPECIFICATIONS, AND APPROPRIATING AN ADDITIONAL NINETY THOUSAND DOLLARS (\$90,000) FROM UNALLOCATED LLAD-88 FUNDS FOR THE AGREEMENT**

**WHEREAS**, On July 15, 2013 the Albany City Council approved the Capital Improvement Plan which included funding for the proposed Public Works Service Center; and

**WHEREAS**, On November 4, 2013 the Albany City Council approved the issuance of a Request for Proposals for the services of a design team to prepare design specifications for the Public Works Service Center; and

**WHEREAS**, The City has received a responsive proposal from the design firm of Gillis + Panichipan Architects (GPa), and the Council desires to enter into an agreement for design services; and

**WHEREAS**, The City Council previously appropriated \$60,000 of LLAD-88 funds for the project and desires to allocate an additional \$90,000 to match the \$150,000 GPa Agreement cost;

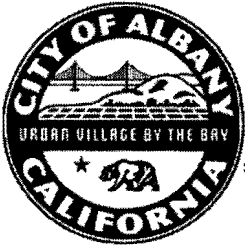
**NOW THEREFORE, BE IT RESOLVED,**

The City Manager is hereby authorized to execute the attached Agreement for Consultant Services with Gillis + Panichipan Architects (GPa) for Public Works Service Center Design Specifications; and

**BE IT FURTHER RESOLVED,**
