A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE PURCHASE OF SELF-CONTAINED BREATHING APPARATUS (SCBA) EQUIPMENT, WAIVER OF FORMAL BIDS, AND THE APPROPRIATION OF FUNDS TO THE CITY OF ALBANY GENERAL EQUIPMENT ACCOUNT (#56214), IN THE AMOUNT OF \$270,240

WHEREAS, the City of Albany, in partnership with the City of Piedmont, have obtained a grant from the Federal Emergency Management Agency Assistance to Firefighters Grant Program in the amount of \$136,802, to fund a portion of the costs for new Self-Contained Breathing Apparatus (SCBA); and

WHEREAS, the City of Albany is the Lead Agency procuring the equipment and administering the grant, which includes equipment for the City of Piedmont; and

WHEREAS, in accordance with the adopted City of Albany purchasing policies, City Council authorization is required for purchases over \$25,000; and

WHEREAS, the total cost of the purchase for both agencies is \$270,239.43; and

WHEREAS, the City of Albany purchasing policy also contains a provision allowing for a waiver of formal bids in the event that the purchase or equipment is part of a government purchasing contract; and

WHEREAS, Fire Department staff at each city researched the various manufacturers and equipment, finding the Scott's SCBA's superior to the other products; and

 WHEREAS, San Ramon Valley Fire Protection District (SRVFPD) recently completed a Request For Quotation (RFQ) process to obtain competitive pricing for SCBA equipment manufactured by Scott following and awarded a purchase to All-Star Fire Equipment Inc., which was the lowest responsible bidder; and

WHEREAS, All-Star Fire Equipment Inc. has agreed to extend the SRVFPD unit pricing to the City of Albany and Piedmont for purchase of the SCBA equipment manufactured by Scott, allowing for purchasing as part of a larger public agency purchasing contract; and

WHEREAS, the City of Albany matching funds for the purchase of the SCBAs is \$ 68,789.36 from Fund 836 Fire Operating Reserve; and

WHEREAS, the City of Piedmont has agreed to provide matching funds to the City of Albany for the purchase of the SCBAs in the amount of \$64,648.

NOW THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the purchase of Self-Contained Breathing Apparatus (SCBA) Equipment and waiver of formal bids in accordance with the City of Albany Purchasing Policy.

BE IT FURTHER RESOLVED, that the Albany City Council hereby approves the appropriation of funds to the City of Albany General Equipment Account (#56214), in the amount of \$270,240.
