#### **PRESENTATIONS**

1. Steve Cassriel of Dodge and Cox presented the investment report for the quarter and year ending December 31, 2007. For the calendar year, the results have not been as in the past, this being due to fluctuations in the market, the sub prime rate problems, Dodge and Cox being over weighted in Health Care specifically Pharmaceuticals, and in Internationals, some of the Japanese companies under performed due to some being IT companies. As for the Japanese companies, Dodge and Cox may have been a little early and still look for them to perform in the future.

There will be no bill for the month of January to cover costs incurred to transfer funds to the new program. In July Steve may not be available to attend the meeting and if so, Bob Thompson will be available to meet with the Board.

2. Scott J. Whalen of Wurts and Associates presented the investment performance report of the quarter ended December 31, 2007.

Due to the market environment, overall Scott feels the fund is in good shape reflected with past performance in spite of this past year. Internationals should smooth and add to the fund. He encouraged the board to look at long-term numbers since short-term numbers may be more volatile.
