RESOLUTION NO. 2014-9

A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING THE CITY MANAGER TO AMEND AN AGREEMENT, IN THE AMOUNT OF \$5,000, WITH CITYGATE ASSOCIATES, LLC TO PERFORM ADDITIONAL ORGANIZATIONAL AND STAFFING REVIEW OF THE PUBLIC WORKS DEPARTMENT, AT A TOTAL AMOUNT NOT TO EXCEED \$29,950

WHEREAS, in 2009, the City hired Citygate to conduct a city organizational assessment, resulting in several recommendations including formation of a Public Works Department; and

WHEREAS, in 2012, the City combined the Public Works Manager position and the consulting City Engineer position into a single Public Works Director position as part of the effort to form an independent Public Works Department; and

WHEREAS, in 2013, the City solicited a Request for Proposals (RFP), and retained the services of Citygate to review and assess the organizational structure, operational functions and levels of staffing within the Public Works Department; and

WHEREAS, Citygate's initial fee (\$24,950) was within the City Manager's purchasing authority, allowing the organizational review to proceed; and

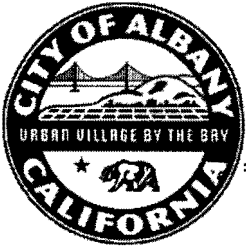
WHEREAS, additional work is needed to properly address the proposed organizational changes to Public Works Department, requiring an amendment to the agreement with Citygate for an additional \$5,000, resulting in a total cost not to exceed \$29,950.
