RESOLUTION NO. 2014-39
APPROVING ACCESSIBLE ON-STREET PARKING SPACES ALONG
SOLANO AVENUE

WHEREAS, the City of Albany is looking to remove barriers for individuals with disabilities; and

WHEREAS, the Traffic and Safety Commission has conducted public processes in 2013 to designate the location of on-street accessible parking spaces along Solano Avenue; and

WHEREAS, in the summer of 2013, installation of five (5) on-street accessible parking spaces was conducted on a trial basis along lower Solano Avenue; and

WHEREAS, the installed parking spaces have been widely used and have removed a barrier to individuals with disabilities, and

WHEREAS, the Traffic and Safety Commission held a public meeting in January 2014 to recommend additional on-street accessible parking spaces along upper Solano Avenue; and

WHEREAS, the Traffic and Safety Commission in its recommendation of proposed accessible spaces took into consideration proximity of the locations to existing driveways, to medical, therapy, and laboratory offices, and the condition of the adjacent sidewalk.



NOW THEREFORE, BE IT RESOLVED, that the Albany City Council hereby approves the location of the on-street accessible parking spaces (previously installed on a trial bases) along lower Solano Avenue at the following five (5) locations:

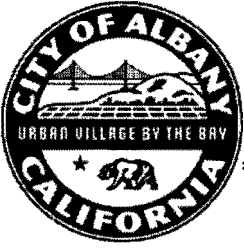
- On Street parking adjacent to 1181 Solano (Albany Medical Group)
- On Street parking adjacent to 1234 Solano (Evelyn Gardens Apartments)
- On Street parking adjacent to 1248 Solano (Jeannie LaDeaux)
- On Street parking adjacent to Flowerland
- Northeast side of the Solano/Adams intersection

BE IT FURTHER RESOLVED, that the Albany City Council approves installation of four (4) additional on-street accessible parking spaces along upper Solano at the following locations:

- 1305 Solano (near Orthodontics)
- 1404 Solano (across from many restaurants)
- 1498 Solano (medical offices and near the Center for Psychological Services)
- 1556 Solano (Cugini's restaurant)
