RESOLUTION NO. 2014-59

A RESOLUTION OF THE ALBANY CITY COUNCIL ADOPTING THE UPDATE TO THE CITY OF ALBANY OPERATING BUDGET FOR FISCAL YEAR 2014-15 AND AUTHORIZING APPROPRIATIONS

WHEREAS, the City Council previously adopted a Fiscal Year 2014-2015 Operating Budget on July 15, 2013 (Resolution No. 2013-42); and

WHEREAS, it is prudent to update projections and estimates contained in the spending plan to reflect the current trends and information available; and

WHEREAS, as part of the update process the format of the Operating Budget is being modified to reflect all funds including the General Fund; and

WHEREAS, it is also prudent for the City Council to adopt administrative parameters for changes to the Budget which may occur during the year; and

WHEREAS, the proposed budget was reviewed by the City Council at a public meeting held by the Albany City Council on June 16, 2014, at which time all interested persons were afforded an opportunity to be heard on matters pertaining to the proposed budget.

NOW, THEREFORE, BE IT RESOLVED by the Albany City Council that the Operating Budget for fiscal year 2014-15 shall be as presented to the City Council on June 16, 2014; and

BE IT FURTHER RESOLVED that a summary of authorized Appropriations is attached hereto and made a part hereof; and

BE IT FURTHER RESOLVED that the City Manager shall be authorized to administratively do the following without further action by the City Council:

a. For the purpose of any General Fund "net assets" remaining at the close of Fiscal Year 2013-2014 the City Manager may assign or transfer funds generally as presented in the Budget Update and based on the final amounts available.

- b. During the Fiscal Year the City Manager shall be authorized to transfer budgeted amounts between line items, provided that the transfer is within the same department activity and fund, provided that an exception shall be allowed under "c" below.
- c. The City Manager shall be authorized to transfer budgets for Utilities and
 Building Maintenance without limiting such transfers to a single department.
 This is necessary to update previously used expenditure allocations.
