## A RESOLUTION OF THE ALBANY CITY COUNCIL ADOPTING THE FISCAL YEAR 2014-2015 TAX RATE FOR THE PENSION OVERRIDE TAX TO FUND CITY OF ALBANY POLICE AND FIRE PENSION OBLIGATIONS

WHEREAS, each fiscal year for the period 1982-1983 through 2013-2014, the City of Albany has levied a pension override tax collected as part of the property tax bill; and

WHEREAS, the rate levied in each of the years from 1982-1983 to 2013-2014 was 0.0993% of the full assessed value of property; and

WHEREAS, prior to setting the rate for Fiscal Year 2014-2015 estimates have been made of the balance of taxes collected and unspent and the projected expenditures for Fiscal Year 2014-2015; and

WHEREAS, the City Council desires to set a tax rate that shall be applied for the Fiscal Year beginning July 1, 2014 and ending June 30, 2015 (Fiscal Year 2014-2015).

NOW, THEREFORE BE IT RESOLVED that the Albany City Council does resolve as follows:

- A) Listed below is the tax rate (expressed as a percentage of full assessed value), which has been calculated by estimating the revenue and tax amounts required to be raised by property taxes to meet certain City pension obligations.
- B) These commitments were created by Chapter IX, Section 9.01 and Chapter IV, Section 4.10 of the voter-approved City Charter.
- C) In accordance with the Charter sections listed above, the figure listed below is hereby adopted as the annual tax rate for Fiscal Year 2014-2015.
