**A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING THE AMENDMENT TO THE FISCAL YEAR 2013-2014 AGREEMENT BETWEEN THE CITY OF ALBANY AND THE COUNTY OF ALAMEDA FOR THE REALLOCATION OF UNEXPENDED AND EXPIRING COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS (CDBG) FROM FISCAL YEAR 2012-2013 IN THE AMOUNT OF \$77,368.99 FOR EXPENDITURE IN FISCAL YEAR 2013-2014 TO THE MINOR HOME REPAIR AND OWNER REHABILITATION PROGRAMS**

**WHEREAS**, the Community Development Block Grant program (CDBG), is one of the longest-running programs of the U.S. Department of Housing and Urban Development (HUD) and the program funds activities such as affordable housing, anti-poverty programs, and infrastructure development that benefit low-income people or contribute to the elimination of blight; and


**WHEREAS**, in order to meet administrative requirements of the program in a cost-effective manner, the cities of Albany, Emeryville, Piedmont, Dublin, Newark, and the unincorporated portions of Alameda County are consolidated as a single "Alameda County Urban County" grantee under the guidelines of the federal Community Development Block Grant (CDBG) program and the HOME Investment Partnership Program (HOME), administered through the federal Department of Housing and Urban Development (HUD); and

**WHEREAS**, staffing for the "Urban County" is provided by Alameda County's Housing and Community Development Department (HCD) and the City of Albany Community and Human Services Manager meets with staff from the County and the other cities every 60 days to monitor the program; and

1           **WHEREAS**, the City of Albany has received Agreement Amendment No. 1  
2 between the City of Albany and the County of Alameda. The amendment modifies the  
3 Fiscal Year 2013-2014 agreement entered on the 1st day of July, 2013 to include  
4 unexpended and expiring CDBG funding from FY2012-2013 in the amount of  
5 \$77,368.99 for expenditure in Fiscal Year 2013-2014 to the Minor Home Repair and  
6 Owner Rehabilitation programs. This contract expires on June 30, 2015.

8           **NOW THEREFORE, BE IT RESOLVED**, that the Albany City Council hereby  
9 approves Agreement ~~Amendment No 1.~~ to the Fiscal Year 2013-2014 agreement between  
10 the City of Albany and the County of Alameda for the reallocation of unexpended CDBG  
11 funding from FY2012-2013 in the amount of \$77,368.99 for expenditure in Fiscal Year  
12 2013-2014 to the Minor Home Repair and Owner Rehabilitation programs.
