9-1. Authorization to Submit the "Working Draft" 2015-2023 Albany Housing Element to the California Department of Housing and Community Development (HCD) for Administrative Review

Planning & Zoning Commission recommendation: on October 8, 2014, the Planning and Zoning Commission recommended that the Council approve submittal of the Working Draft Housing Element to HCD

Staff recommendation: that the City Council authorize staff to submit the Housing Element to the State Department of Housing and Community Development for Administrative Review

Community Development Director Jeff Bond delivered the staff report, and Consultant Barry Miller provided a presentation. All cities and counties in the Bay Area are required by state law to adopt new Housing Elements by January 31, 2015. The Housing Element presents the City's policies for housing production, conservation, and affordability, and demonstrates the City's ability to accommodate its "fair share" of the region's housing need. "Fair share" is calculated roughly every eight years by the Association of Bay Area Governments (ABAG) through a process called the Regional Housing Needs Allocation (RHNA). During the upcoming planning period (2015-2023), the RHNA is 335 units, including 145 above moderate-income units, 57 moderate-income units, 53 low-income units, and 80 very low-income units. City staff is requesting authorization from the City Council to submit a Working Draft of the 2015-2023 Housing Element to HCD. HCD will provide feedback to the City by December 2014 indicating any revisions to the document that it deems necessary before they can issue a compliance determination. The City will incorporate these revisions as appropriate and bring the Housing Element back to the City Council for adoption.

The Housing Element is one of the seven mandated elements of the Albany General Plan. It includes goals, policies, and action programs to conserve existing housing, produce new housing, provide housing for persons with special needs, and ensure equal access to housing by all residents. The contents of the Element are set by State law.

The Planning and Zoning Commission held study sessions on the new (2015-2023) Element on July 23, September 10, September 24, and October 8. On September 30, the City hosted an "Affordable Housing Symposium" including presentations by local housing professionals and a Q&A session.

A summary of comments is as follows: encouraged moving forward with the Housing Element and noted that the work will help the City be in a better position for grants; noted that this is a draft document and additional items may be added later; expressed support and encouraged the inclusion of a drop-in facility for people seeking assistance with housing; the draft is a good example of the community and City working together, encouraged looking into increasing staffing levels to better implement projects.

9-2. North County Winter Relief - Inclement Weather Response Program

Staff recommendation: that the Council adopt Resolution No. 2014-95, authorizing the City Manager to enter into a Memorandum of Understanding with the County of Alameda for the City of Albany's participation in the North County Inclement Weather Response Program between November 15, 2014 – April 15, 2015 and allocate \$15,000 of Council Discretionary Funds to the program

Community and Human Services Manager, Isabelle Leduc delivered the staff report. The County of Alameda along with the cities of Albany, Berkeley, Emeryville and Oakland are collaborating to implement a North County Inclement Weather Response Program that will include warming centers, additional shelter beds, street outreach, vulnerability screening and rapid re-housing funds.

The program includes a limited number of additional winter shelter beds, asneeded warming centers located in both Berkeley and Oakland, outreach-based targeted interventions, rapid re-housing programming, and housing assistance. This combination will provide both broad outreach and warming centers to help people through the colder months, as well as longer term rapid re-housing interventions.
