14 to fulfill its policing mission; and

15 **WHEREAS**, Folsom Lake Ford can provide law enforcement vehicles to local
16 government agencies according to contract #1-12-23-14; and

17 **WEREAS**, contract #1-12-23-14, is a cooperative purchasing contract with the
18 State of California, Department of General Services, Procurement Division, which allows
19 for local government agencies to benefit from the state competitive bidding and vendor
20 selection process; and

21 **WEREAS**, Albany Municipal Code §2-27.2 authorizes the City to use said
22 cooperative purchasing contracts;

23 **NOW, THEREFORE, BE IT RESOLVED**, that the Albany City Council
24 hereby authorizes the appropriation two (2) Ford Police Interceptor Utility Vehicles
25 under State of California procurement contract #1-12-23-14 utilizing COPS Program

WHEREAS, Folsom Lake Ford can provide law enforcement vehicles to local government agencies according to contract #1-12-23-14; and

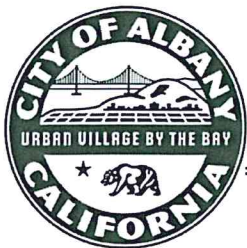
