2 **A RESOLUTION OF THE ALBANY CITY COUNCIL, COUNTY OF ALAMEDA,**
3 **STATE OF CALIFORNIA, DECLARING THE RESULTS OF THE GENERAL**
4 **MUNICIPAL ELECTION HELD ON NOVEMBER 4, 2014**

6 **WHEREAS,** a General Municipal Election was held and conducted in the City of
7 Albany, County of Alameda, State of California, on November 4, 2014, as required by
8 law; and

11 **WHEREAS,** it appears that notice of said election was duly and legally given,
12 that voting precincts were properly established, that election officials were appointed and
13 election supplies furnished, and that in all respects said election was held and conducted,
14 and the votes cast thereat received and canvassed and the returns thereof made and

18 **WHEREAS,** the City Council of the City of Albany met at the Council Chambers
19 of the City Council on Monday, December 8, 2014 to canvass the returns of said election,
20 as a result of which the City Council finds the number of votes cast, the names of the
21 persons voted for, and other matters required by law to be as hereinafter stated.
