A RESOLUTION OF THE ALBANY CITY COUNCIL APPROVING THE UPDATED SALARY SCHEDULE FOR CITY EMPLOYEES

WHEREAS, Section 9 of the Personnel Rules and Regulations as adopted by Resolution 01-59 establishes that the City Council shall adopt salary ranges for each classification; and

WHEREAS, On September 2, 2014 the City Council adopted a Salary Schedule as part of Resolution 2014-77; and

WHEREAS, the City Salary Schedule is periodically updated to reflect any changes in classifications and salaries; and

WHEREAS, the Memorandum of Understanding between the City of Albany and Albany Fire Fighters' Association (AFFA), effective January 1, 2014, provides salary increases effective January 5, 2015; and

WHEREAS, these increases result in three police classifications receiving a slight increase in longevity pay due to its calculation based on an AFFA salary benchmark;

NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby adopts and confirms the Salary Schedule contained in Exhibit A and by reference made part of this Resolution;

BE IT FURTHER RESOLVED, that the Salary Schedule adopted replaces the Schedule as adopted by Resolution 2014-77. MAYOR
