**NOTES:**

- 1 For parcels with additional non conforming uses, the charge will be based upon the ERU for the use code plus the sum of the ERU for each non conforming use.
- 2 n = number of residential units less than or equal to 5.
- 3 m = number of residential units greater than 5.
- 4 ERU = Equivalent Residential Units
- 5 Vacant or Parking Lot assumes no sewer service
- 6 Resolution #2010-39 approved by Albany City Council on July 19, 2010 authorized rates to be increased by \$2 per month plus the change in the CPI for the next five successive years (2010-11 through 2014-15).
- 7 CPI = Consumer Price Index - annual average distributed by the Bureau of Labor Statistics (BLS) for the Consolidated Metropolitan Statistical Area covering San Francisco - Oakland - San Jose. (2013 = 2.242%)
- 8 The rate for unclassified sewer service indicated by an asterisk ( \* ) shall be based upon a comparison with the reasonable estimated sewage discharge for an equivalent (single-family) residential unit (ERU).  
According to a previous study, the estimated wastewater flow contribution per ERU is 168 gallons per unit per day. Assuming 70% of the water consumed by a ERU is 168/0.7 or 240 gallons per unit per day, the monthly rate for unclassified use shall be calculated as the average metered consumption in gallons per month for the preceding 12 month period divided by 240 x 365/12.
- 9 The annual charge is calculated as the monthly rate times 12. Minimum annual charge FY 2014-15 is \$459.52
