2 **A RESOLUTION OF THE ALBANY CITY COUNCIL ACCEPTING THE**
3 **THOMSEN FAMILY GIFT TO THE CITY OF A MEMORIAL BENCH**
4 **AND PLAQUE IN MEMORY OF DIANNA AND PEGGY THOMSEN TO**
5 **BE INSTALLED IN PIERCE STREET PARK**

7 **WHEREAS**, the Thomsen Family has requested to have a Memorial Bench and
8 Plaque placed in Pierce Street Park commemorating the lives of Peggy and Dianna
9 Thomsen; and

11 **WHEREAS**, Peggy Thomsen was a driving force in the creation of Pierce Street
12 Park and served the community for many years on the school board, the City Council and
13 as Mayor; and

15 **WHEREAS**, the Thomsen Family has submitted a request in writing to the City
16 Manager to select one of the new park benches in Pierce Street Park, and will provide a
17 plaque for installation on the bench in memory of Diana and Peggy Thomsen; and

19 **WHEREAS**, the application was reviewed according to the criteria established in
20 the "Administrative Procedures for Acceptance of Gifts to the City" by the City Manager
21 and Parks and Recreation Commission and it is recommended that the application be
22 approved; and

24 **WHEREAS**, if approved by Council, the Recreation and Community Services
25 Director will work with the Thomsen Family to select the bench after the Pierce Street
26 Park construction is complete.

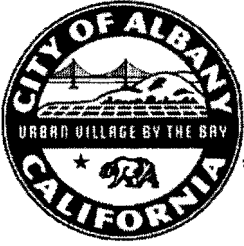
