

**ORDINANCE NO. 2015-02**

**AN ORDINANCE OF THE ALBANY CITY COUNCIL ADDING SECTION 9-10.14 TO  
CHAPTER IX OF THE ALBANY MUNICIPAL CODE ESTABLISHING  
REGULATIONS FOR PARKING OF VEHICLES IN WATERFRONT AREAS WITHIN  
THE CITY OF ALBANY**

**WHEREAS**, Chapter IX of the Albany Municipal Code provides regulations for motor vehicles and traffic within the City of Albany; and

**WHEREAS**, in order to facilitate orderly public access via motor vehicles during times when Albany Waterfront Areas and the McLaughlin East Shore State Park are open to the public and to discourage unauthorized access when these Areas and Park are closed, the City of Albany wishes to establish additional regulations governing the stopping or parking of motor vehicles within its Waterfront Areas.

**NOW THEREFORE, THE ALBANY CITY COUNCIL DOES HEREBY ORDAIN AS FOLLOWS:**

**Section 1.**

Section 9-10.14, entitled "Parking in Waterfront Areas," is hereby added to Chapter IX of the Albany Municipal Code, to read as follows:

**9-10.14 Parking in Waterfront Areas**

a. As used in this Section 9-10.14, the term "Waterfront Areas" shall include but not be limited to those public areas west of the freeway which lie between Albany's northern and southern boundaries.

b. Subject to other and more restrictive limitations, a vehicle may be stopped or parked in a west-bound direction within eighteen inches (18") of the curb line along the north side of the Buchanan Street extension west of the freeway in locations designated as parallel parking spaces.

c. Subject to other and more restrictive limitations, angle or perpendicular stopping or parking is permitted in locations designated as angle or perpendicular parking spaces adjacent to the Buchanan Street extension west of the freeway.

d. Stopping or parking of vehicles within Waterfront Areas shall be subject to a time limit of two hours.

e. Stopping or parking of vehicles within Waterfront Areas is prohibited during the hours between 10:00 p.m. and 5:00 a.m.

f. The City Traffic Engineer is authorized to install appropriate improvements, markings, striping and signage to designate locations within Waterfront Areas where parallel, angle or perpendicular parking is permitted and to post appropriate signage notifying the public of the two-hour time limit and the prohibition on stopping or parking during the hours between 10:00 p.m. and 5:00 a.m.

**Section 2.**

If any section, subsection, sentence, clause or phrase of this ordinance is held to be invalid, such decision shall not affect the validity of the remaining portions of the ordinance, and each section, subsection, sentence clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid.

**Section 3.**

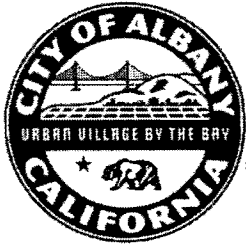
After adoption, this ordinance shall be posted at three public places within the City of Albany and shall become effective thirty days after the date of its posting.
