**A RESOLUTION OF THE ALBANY CITY COUNCIL AUTHORIZING
SUBMISSION OF A GRANT APPLICATION TO THE METROPOLITAN
TRANSPORTATION COMMISSION'S PROGRAM FOR ARTERIAL
SYSTEM SYNCHRONIZATION (PASS PROGRAM)**

WHEREAS, the Metropolitan Transportation Commission (MTC) provides technical assistance to jurisdictions for the Program for Arterial System Synchronization (PASS); and

WHEREAS, the City of Albany traffic signals are currently not synchronized; and

WHEREAS, the signals on San Pablo Avenue and Buchanan Street will be synchronized through the upcoming I-80 Integrated Corridor Management Project (I-80 ICM); and

WHEREAS, five signals on Solano Avenue and Marin Avenue require synchronization in order for the Marin/Buchanan and Solano Avenue corridors to be completely synchronized when the I-80 ICM takes place; and

WHEREAS, signal synchronization provides for uniform traffic flow, reducing stop and go traffic, and reducing greenhouse gas emissions; and

WHEREAS, the grant requires matching funds and additional funds for software upgrades to the controllers of the Solano Avenue signals that would enable the City to synchronize all its signals along the corridors.

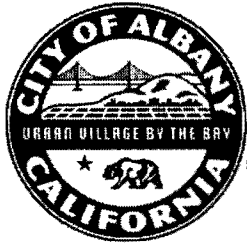
NOW, THEREFORE, BE IT RESOLVED, that the Albany City Council hereby authorizes the submission of the PASS application to MTC.
